**USE OF FORM 316**

Use of Form 316 is appropriate for consent to the transfer of control of Tufts University, the licensee of noncommercial educational station WMFO(FM), Medford, Massachusetts, from the former Board of Trustees to the current Board of Trustees of the University.

This application is being submitted because incrementally, over time, the majority of the Board of Trustees has changed from the membership previously approved by the Commission. Charter trustees are elected by the Board of Trustees to serve on the Board for five year terms. Alumni trustees are elected by ballot of the alumni to serve on the Board for five year terms, or for the remainder of the term of a vacant seat. Elections are held annually to fill seats whose terms have expired or have been vacated. The current members of the Board of Trustees are attached hereto as Attachment I.
