Re: KLOS – Assignment of Rights

Dear Mr. Trujillo:

Reference is made to that certain Asset Purchase Agreement ("Agreement"), dated as of April 5, 2019 by and among Radio License Holdings, LLC ("RLH"), and KLOS – FM Radio Assets, LLC (collectively, "Seller") and Meruelo Media LLC ("Buyer"), and Local Marketing Agreement ("LMA"), dated as of April 5, 2019 between Buyer and RLH. Capitalized terms used herein shall have the meanings ascribed to them in the Agreement and LMA.

Pursuant to Section 13.7 of the Agreement, Buyer hereby (i) assigns to KLOS Radio Holdings, LLC ("Radio Holdings") its rights and obligations under the Agreement to acquire the FCC Authorizations used in the operation of radio station KLOS(FM), Los Angeles, California (Facility ID 35078); and (ii) assigns to KLOS Radio, LLC ("KRL") its rights and obligations under the Agreement to acquire the Station Assets (excluding the FCC Authorizations), and its rights and obligations under the LMA. Radio Holdings hereby accepts the foregoing assignment and assumes and agrees to perform and discharge when due all lawful obligations under the Agreement. KRL hereby accepts the foregoing assignment and assumes and agrees to perform and discharge when due all lawful obligations under the Agreement and LMA.


Notwithstanding anything herein, in accordance with Section 13.7 of the Agreement, (i) this assignment shall not release Buyer of any of its obligations under the Agreement or the LMA; (ii) Buyer, Radio Holdings, and KRL shall be jointly and severally liable for all obligations under the Agreement, and (iii) Buyer and KRL shall be jointly and severally liable for all obligations under the LMA.




