DESCRIPTION OF TRANSACTION

The instant application requests consent to a *pro forma* assignment of the FCC licenses held by Assignor in connection with a petition for Chapter 11 bankruptcy filed by the Assignor in the United States Bankruptcy Court for the Southern District of New York Manhattan Division. The instant application is one of a series of *pro forma* applications filed contemporaneously on behalf of various entities affiliated with the Assignor that also hold FCC licenses and are under the ultimate control of Young Broadcasting Inc. ("Young").

On February 13, 2009, Young, along with the Assignor and certain of Young's other subsidiaries, filed voluntary petitions for bankruptcy seeking to reorganize under Chapter 11 of the U.S. Bankruptcy Code. On February 17, 2009, the Bankruptcy Court entered an order directing the joint administration of all of the Young-related Chapter 11 Cases. *See In re Young Broadcasting, Inc., et. al.*, Case No. 09-10645 (AJG) (Chapter 11) (Jointly Administered) (Bankr. S.D.N.Y.). A copy of Young's initial Petition for Bankruptcy and a copy of the Bankruptcy Court's Order Directing Joint Administration of Young's Chapter 11 cases are attached to Exhibit 5 of this application.

As a result of the bankruptcy filings, the FCC licenses held by each Young subsidiary are being assigned from the licensee company to the licensee company as debtor-in-possession, and each Young subsidiary is now operating as a debtor-in-possession under the Bankruptcy Court's oversight as follows:

The instant *pro forma* assignment does not effect a substantial change in control of Young's FCC licenses, as the directors and officers of Young remain unchanged following the filing of the bankruptcy petitions. Control of Young and its broadcast-licensee subsidiaries, including the Assignor/Assignee, remains the same as it was before, subject to the jurisdiction and oversight of the Bankruptcy Court.
