



## EXECUTIVE SUMMARY


This FCC Form 302-AM has been prepared in accordance to special condition #2 on construction permit BP-20190507ABW, pursuant 73.3536.

Traditionally, 73.1620 Programs Tests states a proof of performance is to be included with the Form 302-AM, however nighttime operation power of 0.013kw precludes us from making a standard field proof. We respectfully request program test authority in absence of the proof.

The array parameters are as required by the current DAD license BL-20030228ATV and the monitor points are below limits prescribed by the DAD license.

Towers and ground system also remain as described in current license BL-20030228ATV, and no patent changes have been made to the antenna system.
