

**Public Interest Statement**  
**FCC Form 301 Question 18 Exhibit 32**

Miriam Media, Inc, (“Miriam”), Auction winner for allotment MM-FM583-A at Ballinger, Texas, hereby submits a Public Interest Statement in support of the application for new construction permit and to change the community of license for FM583-A from Ballinger, Texas to Miles, Texas and to simultaneously upgrade the station from a Class A to a Class C3 facility (the “Application”). As demonstrated below, the proposed changes serve the public interest by providing a first local service to the community of Miles, Texas, while not removing the only local FM broadcast service licensed to Ballinger, Texas.<sup>1</sup> Thus, the proposed change constitutes a preferential arrangement as a Priority 3, under the *FM Priorities*.<sup>2</sup>

**I. Technical Compliance**

This Application proposes the assignment of Channel 238A from Ballinger, Texas to Miles, Texas, and a simultaneous upgrading class upgrade for this allotment by substituting Channel 238A with Channel 238C3 at such location, and issuing Miriam Media an initial construction permit to operate on Channel 238C3 at Miles, Texas based on the transmit site proposed in the attached application. Additionally, because Miles is not located within the defined boundaries of any Urbanized Area and the proposed station will not place a 70 dBu contour over 50% or more of any “Urbanized Area” including

that of San Angelo, Texas, a nearby city with a population in excess of 88,439,<sup>3</sup> a “Tuck” showing is not required as part of this Public Interest Statement.<sup>4</sup>

An Applicant wishing to change a station’s community of license, must specify a channel that is mutually exclusive with the existing station’s channel and the new community must constitute a preferred allotment in accordance with the Commission’s FM allotment priorities discussed above.<sup>5</sup> The proposed assignment of Channel 238C3 to Miles, Texas at either the Miles, Texas reference coordinates or the proposed transmit site would be mutually exclusive with the existing assignment of Channel 238A to Ballinger, Texas. Additionally, the proposed assignment of Channel 238C3 to Miles, Texas at the Miles, Texas reference site satisfies the Commission’s minimum distance separation requirements contained in 47 CFR § 73.207 and will provide the requisite community coverage set forth in 47 CFR § 73.315.<sup>6</sup> Further, while the proposed facility will not serve any white or grey area, neither will it create any such areas by virtue of the proposed changes. However, importantly, the proposed assignment of 238C3 to Miles, Texas will provide that community with its first local service, while not removing the first local service from Ballinger, Texas.

## **II. The Proposed Changes Serve the Public Interest**

The Application proposes changes to the communities of Ballinger and Miles, Texas, that will result in a preferential arrangement under the *FM Priorities* and therefore serves the public interest. The proposed assignment of Channel 238C3 to Miles, Texas serves the public interest by providing a first local service for Miles, Texas as well as providing improved service to more than 109, 520 persons. In accordance with the *FM Priorities*, the proposed assignment represents an enhanced allotment priority over retention of Channel 238A in Ballinger as a second local service, because the allocation will result in the introduction of a first local service as well as enhanced wide-area service. First local service constitutes priority (3) under the *FM Priorities*, while retention of the existing allotment in Ballinger represents at best priority (4). Accordingly, the proposed changes specified in this Application are preferential and serve the public interest.

## **III. Community of License**

As discussed in detail below, Miles, Texas constitutes a “Community” for allotment purposes in accordance with Commission precedent. The Commission has stated that, in order to qualify as a Community for allotment purposes, a locality must have “social, economic, cultural or governmental indicia” that identify that locality as a Community.<sup>7</sup> An applicant may satisfy the showing of community status, by demonstrating that the locality “is commonly regarded as a distinct group,” which can be shown “by objective indications of the existence of a common perception that a locality’s

populace constitutes a distinct geographical population.”<sup>8</sup> The Commission has held that objective indications of Community status include the existence of political, commercial, social and religious organizations and services in the community where the residents function and conceive of themselves as residents of a community. Miles, Texas has sufficient objective indicia of Community status, which are described in more detail below.

While Miles Texas is located within 21 miles of the city limits of San Angelo, Texas, the proposed FM Station on Channel 238C3 would not place a city grade contour over 50% of the San Angelo Urbanized Area. Accordingly, the Commission’s Rules and policies do not require a so-called Tuck showing regarding the independence of the city of Miles, Texas from the Urbanized Area of nearby San Angelo.<sup>9</sup> However, from the discussion below, it is evident that Miles, Texas is independent of the neighboring Urbanized Area and easily satisfies the requirements to qualify as a community for allotment purposes.

Miles, Texas was incorporated in 1905, and at one time was larger than nearby city of San Angelo. Miles has a rich history, with origins tied to the construction of the Santa Fe Railroad. It counts among its buildings, a vintage 1904 Opera House, which is now on the National Register of Historic Places.

The city of Miles, Texas lies midway between Ballinger and San Angelo, Texas and is home to more than 850 residents. The City has its own zip code and a post office (located at 300 Robinson Street), both indicative of an established community. The City has its own website which, among other things, lists more than 50 commercial businesses in Miles, Texas, that provide all manner of services to the community including: banking and financial, insurance, construction, dairy, livestock, trucking, manufacturing, automotive, accounting, daycare, messenger and real estate.<sup>10</sup> Miles residents also have a number of retail options including restaurants,<sup>11</sup> convenience,<sup>12</sup> grocery<sup>13</sup> and other specialty stores. Miles has no fewer than five local churches located in the community<sup>14</sup>. Several elementary, middle and high schools are located in Miles including: Grape Creek Special Program, Miles Elementary, Fairview Accelerated and Miles High School. The community has its own local government, including a Mayor, Vice Mayor, Water Superintendent, a five member City Council, a Municipal Judge, a city evening patrol officer, and a volunteer fire company. The City also has its own local ordinances, a city real estate tax, a city sales tax and city specified charges for water, sewer and trash removal.<sup>15</sup> In short, Miles has the various indicia including education, business, retail,

services, churches and local government that qualify it as a Community for allotment purposes deserving of a first local broadcast service.<sup>16</sup>

**CONCLUSION**

The Application proposes the following FM community changes:


This proposal will serve the public interest by providing the community of Miles, Texas with a first local service while not depriving Ballinger of its own first local service, and additionally providing wide-area service to 109,520 people, which represents 102,397 more people than the Class A station at Ballinger would serve, and even includes the residents of the Ballinger area. For these reasons and those set forth in the attached Engineering Exhibit, Miriam Media respectfully requests that the Commission grant this application with the requested minor community change and on channel Station Class upgrade, and issue Miriam Media a construction permit for 238C3 at Miles, Texas in furtherance of the public interest convenience and necessity.



The City of Miles also levies permit fees.

### SECURITY

Runnels County Sheriff's Department.

A Night watchman employed by the City of Miles.

The Miles Volunteer Fire Department provides fire protection.

Ballinger Memorial Hospital EMS provides ambulance service.

A volunteer animal control/welfare group does rescue work if necessary.

**WATER**

Water is supplied by the City of Miles through a pipeline and water wells.

**RATES**

Basic water rates are \$30 per month with the first 2,000 gallons of water included in this amount.

\$2.50 per gallon for water usage of 2,000 to 30,000 gallons per month.

\$3.50 per gallon for water usage of 30,000 gallons or more per month.

Sewer rates are \$7.00 per month.

The City of Miles requires a \$100 deposit for new water accounts. A \$25 fee will be levied to turn water back on that has been disconnected due to a late or zero payment. A \$50 fee will be levied for the same if it occurs after normal office hours or on weekends.

Garbage rates are \$11.30 plus 88 cents per month.

Garbage disposal is handled through Duncan Disposal in San Angelo. Residential trash is picked up every Monday. Business dumpster trash is picked up every Thursday.

The area is rolling plains with farming and ranching.


