Articles of Incorporation of New York Catholic Radio, Inc.

Under Section 402 of the Not-For-Profit Corporation Law

FIRST: The name of the corporation is: New York Catholic Radio, Inc.

SECOND: The corporation is a corporation as defined in subparagraph (a)(5) of Section 102 (Definitions) of the Not-For-Profit Corporation Law.

THIRD-PART A: The purpose or purposes for which the corporation is formed are as follows:

The corporation is being formed to provide diverse religious and educational radio broadcasting in the Poughkeepsie, New York region. The benefits of the corporation's radio broadcasting will be to provide unique artistic musical production, local sports-related coverage and cultural programming not being heard on local radio. The corporation will achieve its purpose by establishing a Low Power FM radio station.

THIRD-PART B: If the corporation is a Type C corporation, the lawful public or quasi-public objective which each business purpose will achieve is:

The objective of this corporation is to improve the moral character of the local community.

FOURTH: The corporation shall be a Type C corporation pursuant to Section 201 of the Not-For-Profit Corporation Law.

FIFTH: The office of the corporation is to be located in the County of Dutchess in the State of New York.
