

## **FIRST AMENDMENT TO TIME BROKERAGE AGREEMENT**

This **First Amendment to Time Brokerage Agreement** is entered this 16th day of December 2019, by and between Truth Broadcasting Corp. (“Truth”) and MAGA Radio Network, LLC (“MAGA” and, together with Truth, the “Parties”).

**WHEREAS**, Truth is the Licensee of Radio Station WJFN (FM), Goochland, Virginia (FCC Facility ID No. 87127) (“Station”); and

**WHEREAS**, Truth and MAGA are parties to that certain Time Brokerage Agreement (the “TBA”) dated October 25, 2018, whereby Truth has granted to MAGA the right to program the Station pursuant to the terms thereof; and

**WHEREAS**, the Parties desire to enter a first amendment to the TBA to clarify certain terms.

**NOW, THEREFORE**, in consideration of the mutual promises set forth in this First Amendment to Time Brokerage Agreement, the Parties, intending to be legally bound, agree as follows:

- A. The text of **Section 1, Sale and Purchase of Broadcast Time**, is deleted in its entirety and replaced with the following:

**1. Sale and Purchase of Broadcast Time.** Commencing on October 25, 2018 and continuing for a term outlined in Schedule A, Licensee hereby sells to Broker and Broker purchases from Licensee all of the broadcast time on the Station seven (7) days per week, subject to the rules and regulations of the FCC and the terms set forth in this Agreement. Broker will broadcast programs, both those it produces and those produced by others who purchase units of program time from Broker for the broadcast of their

programming, including talk programs, news, sports, religious programs, public service announcements and related materials, including commercial announcements, of its choosing; provided, however, that Licensee shall at all times retain the right to reject any Broker programming that Licensee determines in its sole discretion is not in the public interest or of service to the Station's community of license. Broker will provide each week of this Agreement to the Station a two (2) hour weekly program dealing with public affairs issues specifically related to Goochland and to the greater Goochland area.

- B. The text of **Section 4, Licensee's Duties; Miscellaneous Regulations, Subsection (a) (viii)**, is deleted in its entirety and replaced with the following:


(viii) Employment (including payment of salaries), supervision and direction of the employees of the Station (i.e., the General Manager and the Chief Engineer);
