

### **OTHER AUTHORIZATIONS**

**Millennium Atlantic City License Holdco, LLC** ("Millennium License Holdco"), a wholly-owned subsidiary of Millennium Atlantic City Holdco, LLC, which in turn is wholly-owned by Millennium Radio Group, LLC ("Millennium Radio"), is the new licensee of WFPG(AM), Atlantic City, New Jersey (FIN: 10448), WFPG-FM, Atlantic City, New Jersey (FIN: 10449), and WPUR(FM), Atlantic City, New Jersey (FIN: 54894). On May 11, 2001, the Commission granted the assignment of licenses for the above-referenced stations from Citadel Broadcasting Company ("Citadel") to Millennium License Holdco. See FCC File Nos. BAL/BALH-20010327AGC, AGD, AGE. These assignments were consummated on June 30, 2001. Millennium License Holdco has also assumed Citadel's rights and obligations pursuant to a time brokerage agreement for radio station WKOE(FM) in Ocean City, New Jersey (FIN: 49984).<sup>1</sup>

**Mercury Capital Partners, L.P.** is also a Member/Special Advisor of Lilly Broadcasting Holdings, LLC, which is the sole member of White Broadcasting, LLC and Lilly Broadcasting, L.L.C. White Broadcasting, LLC is the licensee of WENY(AM), Elmira, New York (FIN: 71510) and WENY-FM, Elmira, New York (FIN: 71509). Lilly Broadcasting, L.L.C. is the licensee of WENY-TV, Elmira, New York (FIN: 71508) and television translator stations W06AR, Hornell, New York (FIN: 7111) and W07BJ, Ithaca, New York (FIN: 71512).

**UBS Capital, LLC**, which is affiliated with Capital Radio through its ownership structure, owns approximately 6.1% of the voting stock in One-on-One Sports, Inc., which is the parent company of One-On-One Sports License of Massachusetts, L.L.C., the licensee of WWZN(AM) (formerly WNRB(AM)), Boston, Massachusetts (FIN: 12789). UBS Capital also indirectly beneficially owns 2.4% through its investment in Crest Funding Partners, L.P. ("Crest"). Crest owns approximately 11% of the voting stock of One-on-One Sports, Inc. The stock held by UBS Capital, LLC in One-on-One Sports, Inc. is voted by Charles J. Delaney.

Millennium Atlantic City II License Holdco, LLC ("Millennium Atlantic City II"), another subsidiary of Millennium Radio, also recently filed applications on FCC Form 314 seeking Commission consent to the voluntary assignment of licenses for radio broadcast stations WBSS-FM, Millville, New Jersey (FIN: 72981) from Press Communications, LLC ("Press") to Millennium Atlantic City II. See FCC File No. BALH-20010611AEE. In addition, on Friday, June 8, 2001, Millennium Central New Jersey License Holdco, LLC ("Millennium Central New Jersey"), also a subsidiary of Millennium Radio, filed an application on FCC Form 314 seeking Commission consent to the voluntary assignment of licenses for radio broadcast stations WKXW(FM), Trenton, New Jersey (FIN: 53458) and WBUD(AM), Trenton, New Jersey (53443) from Press to Millennium Central New Jersey. See FCC File Nos. BAL/BALH-20010608AAQ, AAR.

One-on-One Sports, Inc., which expects to consummate the sale of WWZN(AM) as soon as practicable, is naturally in the process of winding down.<sup>2</sup>

Mr. Handy is a member of Millcreek Broadcasting, L.L.C. ("Millcreek"), the licensee of KWKD(FM), Randolph, Utah (FIN: 88272), KUUU(FM), Tooele, Utah (FIN: 37876), KUDD(FM), Roy, Utah (FIN: 33438), KFVR-FM, Nephi, Utah (FIN: 72769), KMXU(FM), Manti, Utah (FIN: 59034) and K272BY, Rural Juab County, Utah (FIN: 59029). Millcreek is the approved assignee of KOVO(AM), Provo, Utah (FCC File No. BAL-20001222ABV, FIN: 65665). Millcreek is also the 100% owner of Rocky Mountain Radio Network, Inc., which is the licensee of KOTB(FM), Evanston, Wyoming (FIN: 20029).
