TECHNICAL STATEMENT

This Technical Statement and attached exhibits were prepared on behalf of Entravision Holdings, LLC ("EH"), licensee of station WNUE-FM, Channel 251C1, Titusville, Florida. EH has pending application to make minor changes to the facilities of WNUE-FM by relocating to another site, slightly lowering the center of radiation above average terrain, decreasing power to 50.0 kilowatts and downgrading to Channel 251C2 (BPH-20080311ACJ). This amendment reduces the height of the tower structure from the proposed 500 feet to 482 feet above ground. However, the proposed center of radiation for WNUE-FM will remain the same due to the use of a five bay antenna in lieu of an eight bay antenna. No other changes are proposed. Therefore all exhibits from the original application are still relevant.

Since EH is proposing to implement this change at a new tower site, the Federal Aviation Administration was apprised of this proposal. A Determination of No Hazard has been issued and the tower has been registered with the Commission and assigned Antenna Structure Registration Number 1261387.

All other necessary documentation used to certify the technical portion of FCC Form 301 has been forwarded to Mega and is available to the Commission upon request.¹
