Dear Mr. Cintron:

This is in reference to the request filed on July 27, 2020. SC requests a further extension of the STA originally granted on February 13, 2013, and last modified on July 13, 2018, to continue ND operation to allow time to file an FCC Form 301 application to permanently modify the licensed facility.<sup>1</sup> In support of the request, SC states that additional time is needed.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA is hereby GRANTED, and SC may continue to operate ND daytime only using the center tower with a maximum of 0.125 kW. SC must reduce power or cease operation if complaints of interference are received, and use

whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR §1.1310. SC must submit an e-mail to my attention to note the date the application was filed.

This authority expires on **February 12, 2021**.
