Dear Counsel:

This is in reference to the request filed October 9, 2007, on behalf of Multicultural Radio Broadcasting Licensee, LLC ("MRB").¹ MRB requests extension of the special temporary authority ("STA") granted on April 9, 2007, for continued operation of Station WHWH with emergency antenna facilities, pursuant to Section 73.1680.

In support of the request, MRB states that it discontinued operation of Station WHWH on April 6, 2006; that it encountered problems with the lessor of the station and the tower owner, and that it was locked out of the transmitter site for a significant period. MRB states that, when it regained access to the site, it found that the station's equipment had been damaged and some essential components removed. MRB further states that it has spent considerable time repairing the equipment and that its engineers still have more work to do and are waiting to receive new equipment to complete the work.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


¹ Station WHWH is licensed for operation on 1350 kHz with 5 kilowatts, unlimited hours, employing different directional patterns during daytime and nighttime hours (DA-2-U).

Our review indicates that the licensee has made progress toward restoration of licensed operation, but additional time is required for completing the work. Thus, extension of STA is warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WHWH may continue to operate with an emergency nondirectional antenna and reduced power not to exceed 1.25 kilowatts. It will be necessary to further reduce power or cease operation if complaints of interference are received. MRB must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **October 1, 2008**.
