Dear Applicant:

On April 22, 2009, the licensee as addressed above was sent a deficiency letter outlining the following interference issue:

Our preliminary engineering review reveals that your proposed facility does not comply with the Commission's interference rules. Specifically, the proposal is predicted to cause interference to the following facilities:

1. WQHA, Aguada, PR. – BPCDT-20080317AEQ

You were given the opportunity to file a minor amendment to resolve the specified interference problem within (30) days from the date of that letter. Amendments must be filed electronically. If not so amended, your application will be considered incomplete and subsequently dismissed.

Our records indicate that on May 21, 2009, you filed an amendment specifically intended to resolve the interference issue as referenced above per the imported exhibit number 2 from your amended proposed construction permit:

**Description:** AMENDMENT DESCRIPTION

THIS AMENDMENT (SECTION III ENGINEERING DATA DIGITAL) PROPOSES TO RELOCATE WVQS-LP TO AN ALTERNATE TRANSMITTER SITE, AND TO EMPLOY A PSI PSILP8ARA ANTENNA WHICH REPLICATES WVQS-LD'S AUTHORIZED ANTENNA PATTERN (ANTENNA CONCEPTS ACS12AR). THE AMENDMENT WAS FILED IN RESPONSE TO AN FCC 30-DAY LETTER WHICH STATED THAT THE WVQS-LD MODIFICATION APPLICATION (BMPDTL-20090415AAD) CAUSED PROHIBITED INTERFERENCE TO THE AUTHORIZED POST-TRANSITION OPERATION OF WQHA ON CHANNEL 50 AT AGUADA, PUERTO RICO.

Our preliminary engineering review including the amended specifications as filed on May 21, 2009, reveals that your proposed facility still does not comply with the Commission's interference rules. Specifically, the proposal is predicted to cause interference to the following facilities:

1. WQHA, Aguada, PR. – BPCDT-20080317AEQ

Therefore, since the specification as filed in the amendment did not resolve the interference issue as outlined in the 30 day deficiency letter dated April 22, 2009, the above referenced proposed application is considered incomplete and IS HEREBY DISMISSED.
