The Applicant's media interests are independent and are not subject to common influence or control of interests held by Applicant's father. There is no commingling of ownership or other interests in media businesses of Applicant on the one hand, and Bobby Caldwell, on the other.

Bobby Caldwell has not been involved in the acquisition or application process for the allotment that is the subject of this application.

In view of the foregoing, Applicant certifies that the proposed facility does not present an issue under the Commission's policies relating to media interests of immediate family members.

Applicant further certifies that the proposed facility:

1. complies with the Commission's policies relating to future ownership interests; and
2. complies with the Commission's restrictions relating to the insulation and non-participation of non-party investors and creditors.
