

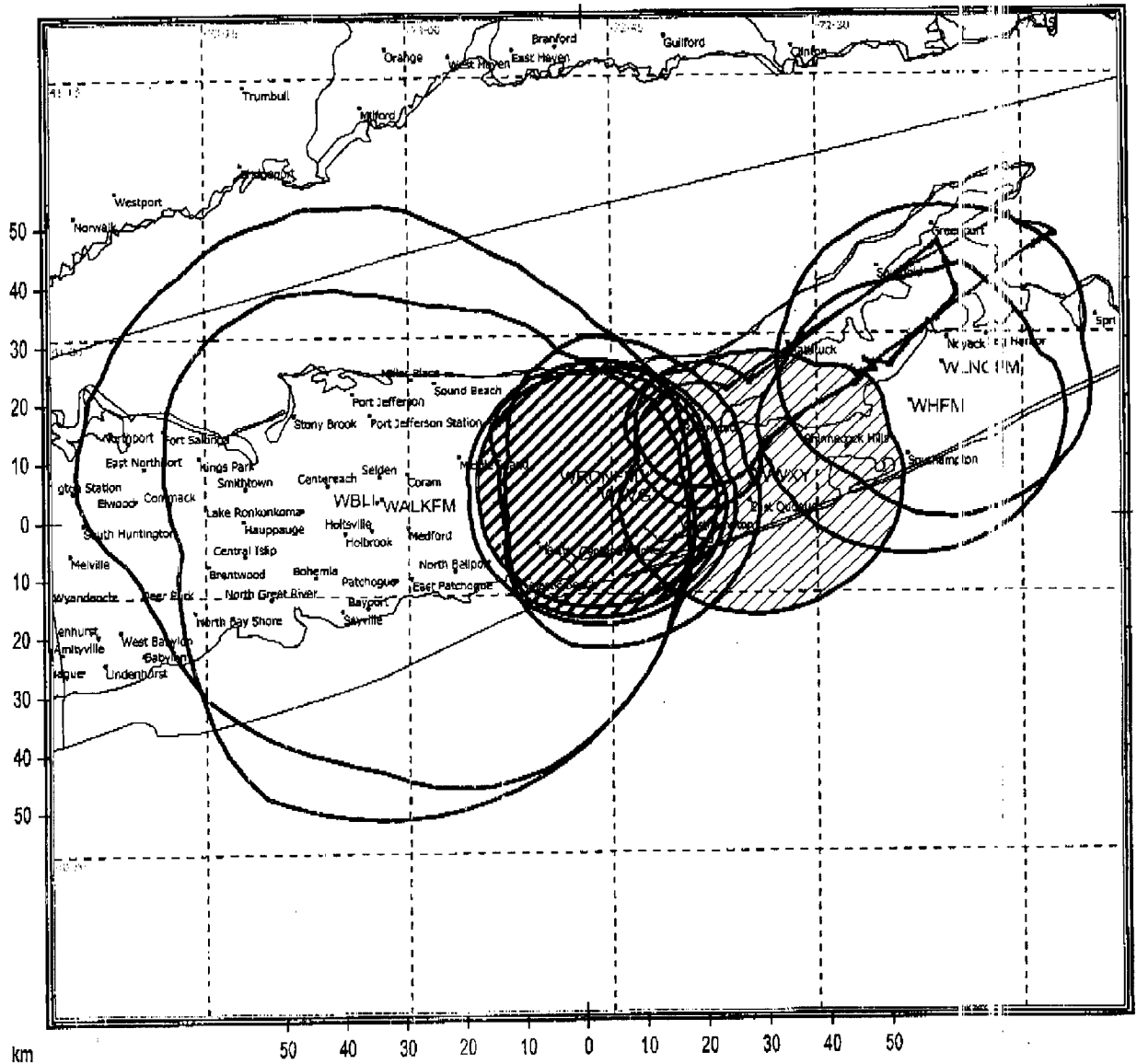
**Multiple Ownership
Compliance Study
For WWXY, Hampton Bays, New York**

This multiple ownership compliance study was conducted to determine if a single party could have an attributable interest in three (3) radio stations in accordance with Section 73.3555 of the Commission's rules. The parties with an interest in Jarad Broadcasting Company of Hampton Bays, LLC ("Jarad"), the proposed assignee for WWXY, also have an attributable interest in WDRE(FM), Westhampton, New York, and WXXP(FM), Calverton-Roanoke, New York. The city grade contours of those three stations were overlaid on a contour map which is annexed hereto as Figure 1.

The market formed by the common contour overlap area of the three stations is comprised of 11 stations, including the three stations in which the assignee parties have an attributable interest. Section 73.3555(a)(1) limits the number of stations in which a party may hold attributable interests in any particular radio market. In radio markets with 14 or fewer commercial radio stations, a party may hold an attributable ownership interest in up to 5 commercial radio stations, not more than 3 of which are in the same service. However, a party may not hold an attributable ownership interest in more than 50 percent of the stations in markets of 14 or fewer stations.

Therefore, Jarad's acquisition of the licenses for WWXY is in compliance with Section 73.3555 of the Commission's rules.
