FORM 340 SECTION II-4 ADVANCEMENT OF EDUCATION PROGRAM

AS A PUBLIC SERVICE AGENCY OF MONTANA STATE UNIVERSITY-BILLINGS, A UNIT OF THE MONTANA UNIVERSITY SYSTEM, THE PROPOSED STATION WILL SERVE THE INFORMATIONAL AND CULTURAL NEEDS AND EXPRESSED DESIRES OF THE GENERAL PUBLIC.

THE PUBLIC SERVICE ACTIVITIES OF MONTANA STATE UNIVERSITY-BILLINGS, INCLUDING THIS STATION, SERVE NO SECTARIAN OR PARTISAN IDEOLOGY OR AGENDA.

ALTHOUGH THE PROGRAMMING FOR THE PROPOSED STATION ORIGINATES FROM BILLINGS, MONTANA, 127 MILES AWAY, A TOLL-FREE 800 NUMBER IS AVAILABLE TO LISTENERS AND OTHER CITIZENS OF SHERIDAN COUNTY TO MAKE SUGGESTIONS AND TO OFFER COMMENTS ON PROGRAMMING AND ON THE QUALITY OF RECEPTION.

PROGRAM GUIDES ARE MADE AVAILABLE TO CITIZENS ON A REGULAR BASIS AT THE SHERIDAN FULMER PUBLIC LIBRARY AT NO CHARGE.

TWICE EACH WEEK, KEMC, THE ORIGINATING STATION IN BILLINGS CONDUCTS A "LIVE" LISTENER CALL-IN DURING WHICH ALL LISTENERS ARE INVITED TO COMMENT ON EXISTING PROGRAMMING AND TO SUGGEST ADDITIONAL PROGRAM SERVICES WHICH MAY SERVE THE PUBLIC INTEREST. EACH MONTH, MORE THAN 100 LISTENERS TAKE ADVANTAGE OF THIS OPPORTUNITY TO SPEAK DIRECTLY TO THE STATION'S STAFF AND MANAGEMENT.

### EXHIBIT 3    SECTION IV    PROGRAM SERVICE STATEMENT

BECAUSE MONTANA STATE UNIVERSITY-BILLINGS SERVES A LARGE AREA OF MONTANA AND WYOMING THROUGH BROADCAST STATIONS AND TRANSLATORS, NEWS AND PUBLIC AFFAIRS PROGRAMS ARE PRIMARILY REGIONAL IN NATURE - PURSUING PUBLIC POLICY QUESTIONS AND ISSUES WHICH AFFECT MOST OR ALL OF THE REGION, AND LOCAL MATTERS WHICH WOULD BE OF INTEREST TO THE LARGER REGION. .

THE PRIMARY ISSUES OF CONCERN TO THE CITIZENS OF SHERIDAN AND SHERIDAN COUNTY, WYOMING ARE COMMON TO MOST OF THE REGION: ISSUES RELATING TO THE POPULATION GROWTH AND ECONOMIC DEVELOPMENT OF THE NORTHERN ROCKY MOUNTAIN/YELLOWSTONE TERRITORY OF MONTANA AND WYOMING, AND HOW THIS GROWTH AND DEVELOPMENT EFFECT THE VAST NATURAL BEAUTY AND WILDLIFE FOUND IN THE REGION'S MOUNTAINS, RIVERS AND FORESTS. MANY CITIZENS BELIEVE THAT THE UNIQUENESS OF OUR NATURAL ENVIRONMENT MUST BE PRESERVED WHILE OTHERS SEE THIS SAME ENVIRONMENT AS A SOURCE OF LIVELIHOOD THROUGH MINING, LOGGING, OIL DRILLING AS WELL AS THE CHANGING LAND AND WATER USE ASSOCIATED WITH POPULATION GROWTH. ALMOST DAILY, THE PROGRAMMING ON OUR STATIONS AND TRANSLATORS RELATE TO THE VARIETY OF SPECIFIC ISSUES WHICH FOLLOW FROM THESE DIFFERING AND SEEMINGLY IRRECONCILABLE VALUES. OUR PROGRAMMING ON THESE ISSUES IS CONSTRUCTIVE AND ENCOURAGES CONSENSUS WHERE POSSIBLE.

ANOTHER AREA OF COMMON INTEREST AND CONCERN TO OUR REGION IS THE RELATIONSHIP BETWEEN THE MEMBERS OF THE EIGHT NATIVE AMERICAN TRIBES INCLUDED WITHIN MONTANA AND WYOMING, AND THE MUCH LARGER POPULATION OF NON-INDIANS. MANY NATIVE AMERICANS RESIDE IN THE CITIES AND TOWNS OF THE REGION WHILE MANY OTHERS LIVE ON RESERVATIONS. UNEASY, DIFFICULT RELATIONS WITH LOCAL, STATE AND FEDERAL GOVERNMENTS IS A NORMAL WAY OF LIFE FOR NATIVE AMERICANS. OUR PROGRAMMING REGULARLY RELATES TO JURISDICTIONAL DISPUTES (INDIAN SOVEREIGNTY ON RESERVATIONS) AND THE LONG HISTORY OF MISUNDERSTANDING AND PREJUDICE BETWEEN INDIANS AND NON-INDIANS IN OUR COMMUNITIES. OUR PROGRAMMING EFFORTS REFLECT HISTORICAL, CULTURAL, SOCIAL, ECONOMIC AND POLITICAL ISSUES, ALL OF WHICH REVEAL ONGOING HUMAN RELATIONS PROBLEMS IN THIS REGION.

OUR DAILY NEWSCASTS REPORT STORIES ON FARMING, RANCHING, PUBLIC RESOURCE MANAGEMENT AND TOURISM--THE MAJOR MEANS OF LIVELIHOOD IN THIS REGION.

IN ADDITION TO REGIONAL COVERAGE, WE PROVIDE SIX HOURS ON WEEKDAYS AND THREE HOURS ON WEEKEND DAYS OF WORLD AND NATIONAL NEWS AND INFORMATION BY WAY OF NATIONAL PUBLIC RADIO (NPR) AND PUBLIC RADIO INTERNATIONAL (PRI) PROGRAMS.

WE ARE THE REGION'S EXCLUSIVE DAYTIME SOURCE OF CLASSICAL MUSIC AND JAZZ PROGRAMMING, AND THE REGION'S EXCLUSIVE SOURCE OF OVERNIGHT CLASSICAL MUSIC. WE ALSO OFFER PROGRAMS OF BLUES AND FOLK MUSIC ON THE WEEKENDS.

WE OFFER WEEKLY PROGRAMS IN SPOKEN ARTS AND HUMANITIES: SHORT STORIES, POETRY AND CULTURAL INFORMATION REFLECTING OUR REGION, THE NATION AND THE WORLD.

AS THE COMMISSION HAS ACKNOWLEDGED IN 98 FCC 2d 746, PUBLIC RADIO STATIONS RELY IN LARGE PART OF THEIR LISTENERS FOR OPERATING REVENUE. IN THIS SPARSELY POPULATED REGION OF MONTANA AND WYOMING, A PUBLIC RADIO SERVICE OF HIGH QUALITY IS POSSIBLE ONLY IF A SUFFICIENT NUMBER OF SUPPORTIVE LISTENERS CAN BE REACHED BY WAY OF REPEATER STATIONS AND TRANSLATORS. THE STATION PROPOSED IN THIS APPLICATION WILL BROADCAST THE PROGRAM SERVICE ORIGINATING AT PUBLIC STATION KEMC AT MONTANA STATE UNIVERSITY-BILLINGS. BILLINGS IS A COMMUNITY OF LESS THAN 100,000 POPULATION. KEMC-FM SERVES APPROXIMATELY 150,000 IN ITS PRIMARY AND SECONDARY COVERAGE AREAS. BY ADDING THE POPULATION TO BE SERVED BY THIS PROPOSED STATION AND OTHER REPEATER STATIONS AND TRANSLATORS IN OUR REGION, WE ARE ABLE TO REACH A POPULATION BASE OF NEARLY 300,000 CITIZENS. FROM THIS POPULATION WE ARE ABLE TO ATTRACT ENOUGH LISTENERS-SUPPORTERS TO FUND 54% OF OUR CURRENT ANNUAL BUDGET OF \$650,000.
