Corban University (formerly known as Corban College and prior to that known as Western Baptist College) has been the licensee of Station KWBX since 2002. As a result of gradual changes in the membership of the Board of Trustees, the University this year reached the point where less than a majority of the board previously has been passed upon by the Commission. The twenty seven members of the current board of trustees are listed below. Ten of those listed (identified by an asterisk) have been members of the board since KWBX was first licensed in 2002.
