Minnesota Public Radio Ownership Information

All Trustees and Officers are US citizens. Members of the Board are elected by the Board and Staff Officers are appointed by the President. Members hold 0% of ownership interest in MPR.

The Board of Trustees of American Public Media Group (APMG) has certain approval rights with respect to organizational documents of Minnesota Public Radio (MPR), appointment of certain members of MPR's Board of Trustees, and the sale of all or substantially all of MPR's assets. Specifically, the Trustees of APMG are also Trustees of the MPR Board. MPR, however, is solely and ultimately responsible for all personnel, programming and financial matters affecting the licensee's broadcast operations. APMG holds 100% of the votes and assets of MPR. MPR is a licensee of the Commission.

1400 Inc. is a for-profit corporation and a licensee of the Commission. MPR owns 100% of the ownership interest in 1400 Inc.

Trustees' reportable interests:

Trustee Anita Kunin's (MPR) four sons and husband collectively own 85% of three TV stations (KVRR, Duluth, MN; KDLT, Sioux Falls, SD; KQDS, Duluth, MN) and three radio stations (KQDS, KZIO, and WWAX, all in Duluth, MN).

Trustee Addison Piper (MPR, APMG) is a Regent of St. Olaf College. St. Olaf College is the licensee of WCAL (FM) in Northfield, MN.

Trustee/officer William H Kling (MPR, APMG, 1400 Inc) and officers Thomas J Kigin (MPR, APMG, 1400 Inc) and Donald Creighton (MPR, APMG) are on the Board of Directors of Comcast of Saint Paul.
