Petition for Reconsideration

Dear Applicants:

We have before us a petition for reconsideration (Petition) filed by Family Unity Outreach Ministry, Inc. (FUOM) and Come Together Productions, Inc. (CTP) (together, Parties) on July 2, 2020. The Parties seek reconsideration of the Audio Division, Media Bureau (Bureau)'s June 5, 2020 dismissal of the above referenced application (Application)¹ for consent to assign the license and sell the assets of low power FM (LPFM) station WMBT-LP, Gainesville, Florida (Station).² For the reasons set forth below, we deny the Petition.

Background. After the Bureau's dismissal of the Application, the Parties filed an amendment (Amendment) to the Application. In the Amendment, the Parties submitted a new asset purchase agreement (APA) with a purchase price of \$14,200.³ The APA includes a listing of the assets, depreciation table with the present claimed value of the assets, and excludes any agreement to make a donation.

In the Petition, FUOM and CTP argue that because the APA lists the tangible goods to be purchased, the goods' total value is lowered for depreciation, and the APA does not include any donations, the APA complies with section 73.865(a) of the Commission's rules (Rules). The Parties request reconsideration of the Application's dismissal, and reinstatement *nunc pro tunc* to make the Amendment and Application acceptable for filing.

Discussion. The Bureau will consider a petition for reconsideration only when the petitioner shows either a material error in the original order or raises additional facts not known or existing at the time of the petitioner's last opportunity to present such matters.⁴ The Parties have not demonstrated that the Letter Order erred in dismissing the Application, and the Amendment does not warrant reinstatement of the Application *nunc pro tunc*.

As detailed in the Letter Order,⁵ the Application as originally filed did not comply with section 73.865 of the Rules⁶ because FUOM did not document the alleged value of the Station's equipment and facilities and proposed a donation as part of the APA.

While the APA in the pending Amendment excludes the donation and reduces the purchase price to reflect a lower value for the Station's assets, the Parties still have not provided any documentation to support a conclusion that the total purchase price does not exceed "the depreciated fair market value of the physical equipment and facilities."⁷ Instead, the Parties merely attach a list of the Station's claimed assets.

Conclusion. For the reasons stated above, we find that the Parties have not demonstrated that the Bureau erred in dismissing the Application, nor submitted a showing in the Amendment warranting reinstatement *nunc pro tunc* of the Application. Therefore, we will deny the Petition and dismiss the Amendment.

Accordingly, IT IS ORDERED, that the Petition for Reconsideration filed by Family Unity Outreach Ministry, Inc. and Come Together Productions, Inc. on July 2, 2020, IS DENIED.

IT IS FURTHER ORDERED that the Amendment filed by Family Unity Outreach Ministry, Inc., to amend the application for consent to assign the license of low power FM station WMBT-LP, Gainesville, Florida, Facility ID No. 196950, File No. BALL-20200218ABC, IS DISMISSED.
