Dear Mr. Jacobs:

This is in reference to the request filed September 18, 2013. RVC requests a second extension of the STA granted on June 19, 2013, to operate station KCKN(AM) with reduced power due to transmitter problems.<sup>1</sup> In support of the request, RVC requested an additional 30 days to complete installation of a used 50 kW transmitter in order to resume licensed operations.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KCKN(AM) may continue to operate during day and night hours with a reduced power of 1 kW. It will be necessary to further reduce power or cease operation if complaints of interference are received. RVC must notify the Commission when licensed operation is restored.<sup>2</sup> RVC must use whatever means are necessary to protect workers and the public from exposure to radio



frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. We anticipate that RVC will file a letter stating the station has resumed licensed operating parameters before the expiration date shown below (or an FCC Form 302 application along with partial proofs if needed to justify any changes).

This authority expires on **June 20, 2014**.
