Dear Counsel:

This is in reference to the request filed June 7, 2013, on behalf of SLC Divestiture Trust I ("SLC"). SLC requests an eighth extension of the special temporary authority ("STA") granted on January 11, 2008, to operate Station KUDE with emergency antenna facilities pursuant to Section 73.1680.<sup>1</sup> In support of the request, SLC states that its engineers are preparing to install equipment and get the station up and running this summer.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

<sup>1</sup> KUDE is licensed for operation on Channel 280C (103.9 MHz) with effective radiated power of 74 kilowatts (H only) and antenna height above average terrain of 684 meters. KUDE holds construction permit BPH-20101220ABB (expires February 28, 2014) for operation with the same facilities, except on Channel 256C (this construction permit was a replacement for expired permit BPH-20040623ABX). The channel change was required by the *Report and Order* in MB Docket 02-290, DA 04-1650, 19 FCC Rcd 10327 (2004).

Construction permit BPH-20071119AEV for KNYN (FM), Fort Bridger, WY on Channel 280C1, awaits implementation of KUDE's construction permit BPH-20101220ABB.

The licensee's statements indicate that progress has been made toward restoring authorized operation, thus, extension of STA is warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KUDE may continue to operate with the following facilities:



SLC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **December 15, 2013**.

**Any future request for extension of this authority must include an attachment documenting SLC's progress in implementing the channel change to Channel 256C required by KUDE's construction permit BPH-20101220ABB.** Failure to provide this information, or providing incomplete information, may result in modification of future STA terms, or cancellation of KUDE's STA authority on Channel 280.
