

## Memorandum of Agreement

Circle S Broadcasting Co., Inc. ("Circle S"), licensee of Station KSWG(FM), Channel 242C, Wickenburg, Arizona, FCC Facility ID No. 11216, and Yavapai Broadcasting Corporation, ("Yavapai") licensee of Station KKLD(FM), and Channel 240C0, Cottonwood, Arizona, FCC Facility ID No. 51642 (collectively, the "Parties"), hereby evince their agreement to each file simultaneously with the Federal Communications Commission ("FCC"), pursuant to the Report and Order in MB Docket 05-210, 71 Fed. Reg. 76208 (December 20, 2006), an FCC Form 301 Application for Minor-Change Construction Permits.

Circle S's Application will specify Channel 242C for KSWG(FM) at a new antenna site. In order to accommodate KSWG(FM)'s proposal, Yavapai's Application will specify Channel 240C for KKLD(FM) at a new antenna site serving a new community of license at Clarkdale, Arizona. In order to also accommodate the KSWG(FM) application, Circle S requests that the Commission issue an Order to Show Cause to Petracom of Holbrook, LLC ("Petracom"), licensee of KRFM(FM) as to why its licensed channel should not be substituted with Channel 295C. Circle S hereby states that it will reimburse Petracom for its reasonable expenses in changing KRFM(FM)'s channel to 295C in accordance with *Circleville, Ohio*, 8 FCC 2d 159 (1967). In order to accommodate the KKLD(FM) application, Yavapai requests that the Commission issue an Order to Show Cause to KM Radio of St. Johns, L.L.C. ("KM Radio"), licensee of KWKM(FM) as to why its licensed channel should not be substituted with Channel 243C. Yavapai hereby states that it will reimburse KM Radio for its reasonable expenses in changing KWKM(FM)'s channel to 243C in accordance with *Circleville, Ohio*, 8 FCC 2d 159 (1967).

Finally, in order to accommodate substitute Channel 295C for KRFM(FM)'s use, Circle S is simultaneously filing a Petition for Rule Making seeking substitute channels of equivalent class for the unused Vacant Allotment and its associated 301 Applications at Pinetop, Arizona, currently assigned Channel 294C1, and the Vacant Allotment at Pima, Arizona, currently assigned Channel 296A. In the Petition, Channel 249C1 shall be substituted for all three sites at Pinetop and Channel 289A shall be substituted at Pima.


A copy of this Memorandum of Agreement will form an attachment to each of the two Applications.
