DESCRIPTION OF PRO FORMA TRANSFER

Grand Ole Opry, LLC (“Opry” or “Licensee”) holds the license for radio station WSM(AM), Nashville, Tennessee (Facility ID #74066). Through several intervening entities, Opry is a subsidiary of ultimate parent company Ryman Hospitality Properties, Inc. (“Ryman”).

In preparing its 2019 Biennial Ownership Reports, Opry became aware of a restructuring involving certain of the intervening entities between the licensee and its ultimate parent, Ryman. The attached diagrams depict the changes to the vertical ownership structure above Opry. Specifically, in December 2019, RHP Hotel Operations Holdco, LLC (“Hotel Holdco”) became a direct subsidiary of RHP Operations and Attractions Holdings, LLC. In turn, RHP Creative Group, Inc. was converted to a limited liability company and became a direct subsidiary of Hotel Holdco. Opry also determined that, in December 2017, Opry Attractions Holdco, LLC and its direct subsidiary, Opry Entertainment Group Holdings, LLC (“Opry Entertainment”), were inserted into the vertical ownership structure immediately below what is now RHP Creative Group LLC.

Opry, the holder of the WSM(AM) license, continues to be wholly owned by Country Music Television International, Inc. (“CMTI”), a direct subsidiary of Opry Entertainment, which is ultimately controlled by Ryman.

Ryman inadvertently overlooked the need to file a *pro forma* transfer of control application at the time of these changes, and this Form 316 seeks *nunc pro tunc* consent to them. As noted, Licensee remains under the control of the ultimate parent, Ryman. Therefore, use of an FCC Form 316 is appropriate.

The officers of each of these new companies are listed below. Each is a U.S. citizen and holds no other broadcast interests. These LLCs do not have directors.


