

TECHNICAL STATEMENT
RADIO MULTIPLE OWNERSHIP ANALYSIS
CONCERNING ACQUISITION OF WAIT(AM)
CRYSTAL LAKE, ILLINOIS

This radio multiple ownership analysis was prepared concerning the acquisition of WAIT(AM), Crystal Lake, Illinois. The following radio stations are to be considered under present or proposed common ownership or control in the area of Chicago, Illinois:

Call Sign	City of License	Facilities
WCSN(AM)	Chicago-IL	820 kHz, 5 kW-D
WAIT(AM)	Crystal Lake-IL	850 kHz, 2.5 kW-D, DA-D
WSBC(AM)	Chicago-IL	1240 kHz, 1 kW-U

The principal community contours of all of these stations are depicted on a map included herein as Figure 1^{*}. The radio multiple ownership analysis considers only those stations with overlapping principal community contours (5 mV/m for AM stations, 3.16 mV/m for FM stations). An ownership study was prepared in accordance with the Federal Communications Commission multiple ownership rules as outlined in Section 73.3555.

^{*} Commonly owned or controlled station WCFJ(AM), Chicago Heights-IL (1470 kHz, 1 kW-U, DA-2) is also shown in Figure 1 for reference. WCFJ is not part of the defined market that includes WAIT.

Radio Markets

The “radio market” applicable to common ownership of the subject stations is defined as the area encompassed by the mutually overlapping principal community contours of the stations proposed to be commonly owned.[†] As listed in the table below, there is one defined “radio market” formed by the subject stations:

Count of Stations in Defined Markets

The number of radio stations in a “radio market” is determined by counting the operating, commercial stations having principal community contours which overlap or intersect the principal community contours which define the radio market, plus the subject stations to be co-owned. Only those stations having principal community contour overlap with the defined market area were employed in the count of stations. The results of the analysis are tabulated below:

Figure 2 is a tabulation of the radio stations identified in the defined radio markets. Only known licensed, operating, commercial stations were employed for the study. Distances to the AM coverage contours were predicted using the antenna patterns as identified in the Commission's AM database and the appropriate Ground Wave Field Strength versus Distance Graph described in Section 73.184 of the FCC Rules. Ground conductivity data were obtained from FCC Figure M3. Distances to the FM contours were determined based on the method outlined in Section 73.313 of the FCC Rules. Terrain data were derived from the U.S.G.S. 3-second computer database for each of the FM stations using radials evenly-spaced every 2 degrees of azimuth.

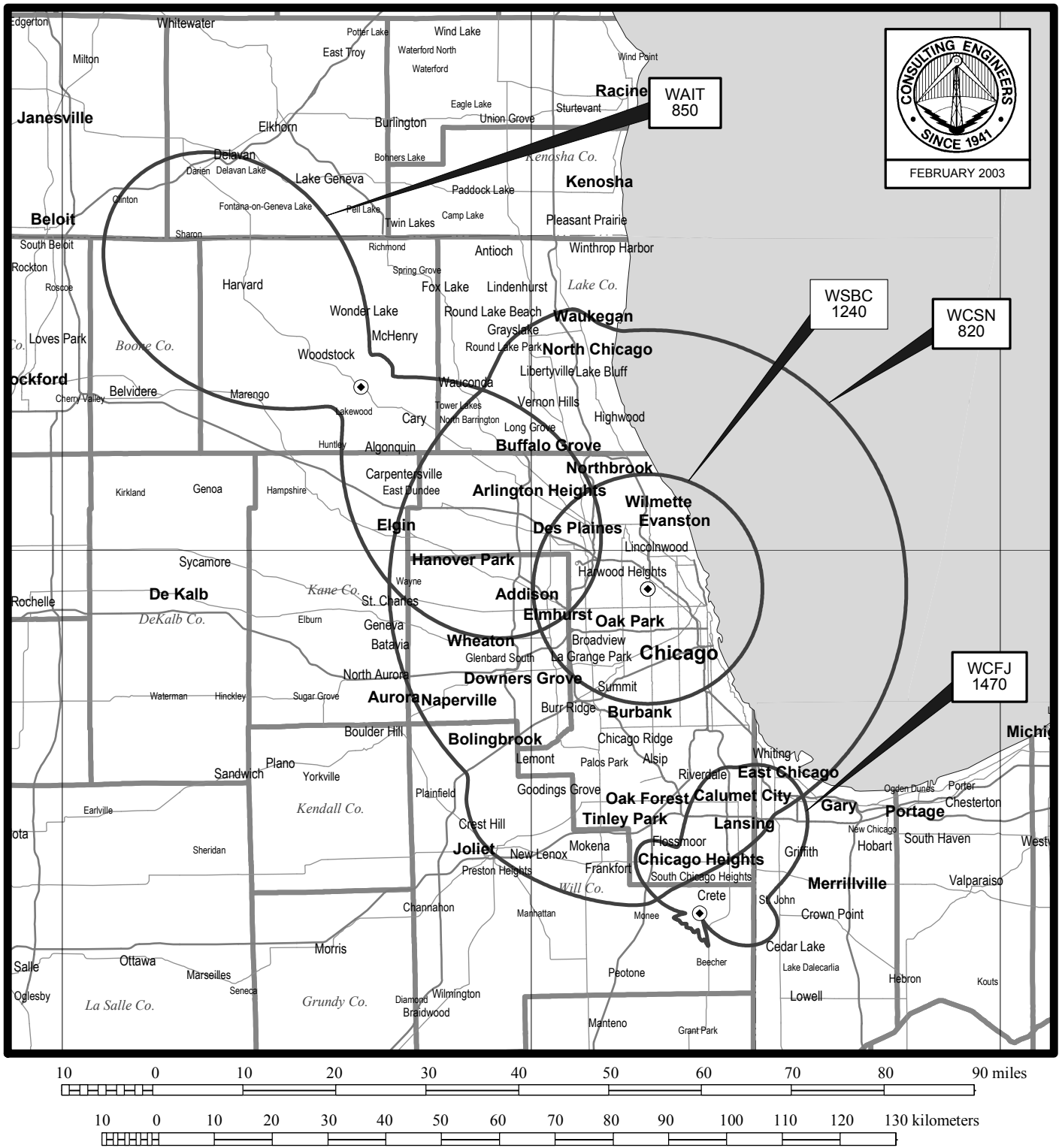
Based on the above, it is concluded that the proposed combination of the stations to be owned complies with Section 73.3555(a) of the FCC Rules.
