Compliance with Multiple Ownership Rule

Oklahoma Land Company, LLC (“Oklahoma Land”) hereby submits this exhibit demonstrating that the acquisition proposed in the underlying application complies with the FCC’s multiple ownership rule. In the instant application, Oklahoma Land proposes to acquire full power television station KUOK(TV), Woodward, Oklahoma and several lower power stations.¹

After the proposed acquisition, Oklahoma Land and its commonly-owned affiliates, Tyler Broadcasting Corporation and Nick Radio LLC (the “Affiliates”), will own two television stations in the Oklahoma City DMA (KTUZ-TV, Shawnee, OK and KUOK(TV)) and five radio stations (KKNG-FM, Newcastle, OK; KOJK-FM, Blanchard, OK; KTUZ-FM, Oklarche, OK; KOCY-AM; Del City, OK; and KTLR-AM, Oklahoma City).

1) Local Television Multiple Ownership Rule: Oklahoma Land’s proposed acquisition of KUOK(TV) complies with the FCC’s local television ownership rule because the contours of KUOK and KTUZ-TV do not overlap even though both stations have been assigned to the Oklahoma City DMA. *See* 47 C.F.R. § 73.3555(b)(1).

¹ The lower power stations are: KCHM-CA, Oklahoma City, OK; KOKT-LP, Sulphur, OK; and KUTU-LP, Tulsa, OK. Since these stations are not covered by the Commission’s multiple ownership rule, Oklahoma Land is free to acquire them with no further showing.

2) Radio-Television Cross-Ownership Rule: As demonstrated in the attached tables, following the proposed acquisition of KUOK(TV) by Oklahoma Land, there will be well over 20 independently-owned media voices in the Oklahoma City market. For this reason, the combined holdings of two television stations and five radio stations by Oklahoma Land and the Affiliates complies with the FCC's radio-television cross-ownership rule. *See* 47 C.F.R. § 73.3555(c)(2)(i).
