SJL of California, L.P.

SJL of California, L.P., licensee of KSBY(TV), San Luis Obispo, California, is a Delaware limited partnership. Its sole general partner is SJL of California, Inc. and its sole limited partner is SJL Communications, L.P. SJL of California, L.P. also controls 100% of the equity and voting control of SJL of Pennsylvania, Inc., licensee of station WICU-TV, Erie, Pennsylvania.

SJL of California, Inc. is a Delaware corporation. SJL of California, Inc. is 100% owned by SJL Communications, Inc., which in turn is 80.90% owned by the George D. Lilly 1997 Business Trust. George D. Lilly is the sole trustee of the George D. Lilly 1997 Business Trust.

SJL Communications, L.P. is a Delaware limited partnership. Its sole general partner is SJL Communications, Inc. Its attributable limited partners include SJL Partners, L.P., a Delaware Limited Partnership; George D. Lilly 1995 Family Trust; Richard B. Armfield; Pamela Davis Heilman; Robert D. McCurdy; George D. Lilly; Weldon B. Paulsen, Carole A. Henery; Lorraine W. Hansen; Sandra G. Benton; and Diana Crants. All other limited partners are insulated. SJL Partners, L.P. is a Delaware limited partnership. Its general partners are the George D. Lilly 1997 Business Trust and SJL Broadcast Management Corp. Its attributable limited partners are Richard B. Armfield, Jr., Diana S. Crants, Carole A. Henery, Denise Hopkins, Lorraine E. Hansen, Robert D. McCurdy, Weldon B. Paulsen, George D. Lilly 1995

Family Trust and George D. Lilly. All other limited partners are insulated. SJL Broadcast Management Corp., a Montana corporation, is 100% owned by the George D. Lilly 1997 Business Trust. The stockholders of SJL Communications, Inc. are The George D. Lilly 1997 Business Trust (80.9%), Richard B. Armfield (10.79%), Robert D. McCurdy (6.74%) and Sandra G. Benton (1.57%).

Mr. Lilly is Chairman and CEO of SJL Northeast License Subsidiary, LLC (“SJL Northeast”), which is licensee of stations WBNG-TV (ID #23337), Binghamton, NY; WTAJ-TV (ID #23341), Altoona, PA; and WLYH-TV (ID #23338), Lancaster, PA.

The sole member of SJL Northeast is SJL Northeast, LLC. Mr. Lilly is also Chairman and CEO of SJL Northeast, LLC. The sole member of SJL Northeast, LLC is SJL Northeast Holdings, LLC. Mr. Lilly is President and a Board Representative of SJL Northeast Holdings, LLC. The 11.11% member of SJL Northeast Holdings, LLC is SJL Broadcast, LLC. Mr. Lilly is Chairman and Board Representative of SJL Broadcast, LLC. The two members of SJL Broadcast, LLC are Lilly Northeast

Broadcast, LLC (50%) and SJL Northeast Broadcast, LLC (50%). Mr. Lilly is a 43% member, Chairman and Board Representative of SJL Northeast Broadcast, LLC.

Pamela Davis Heilman

Pamela Davis Heilman is Secretary and a Director of SJL of Pennsylvania, Inc. Ms. Heilman is also Secretary and a Director of SJL of California, Inc. In addition, Ms. Heilman is Secretary and a Director of SJL Communications, Inc. Ms. Heilman is also a limited partner, with a 0.92% equity interest, in SJL Communications, L.P. In addition, Ms. Heilman is a trustee of the George D. Lilly 1995 Family Trust.

Ms. Heilman is Secretary of SJL Northeast and its sole member, SJL Northeast, LLC. Ms. Heilman is also Secretary of SJL Broadcast, LLC, an 11.11% member of SJL Northeast Holdings, LLC, which, in turn, is the sole member of SJL Northeast, LLC. SJL Northeast Broadcast, LLC is a 50% member of SJL Broadcast, LLC. Ms. Heilman is Secretary of SJL Northeast Broadcast, LLC.

Robert D. McCurdy

Ms. Benton is also Vice President and a Board Representative of SJL Broadcast, LLC, an 11.11% member of SJL Northeast Holdings, LLC, which, in turn, is the sole member of SJL Northeast, LLC. SJL Northeast Broadcast, LLC is a 50% member of SJL Broadcast, LLC. Ms. Benton is a 43% member, President and a Board Representative of SJL Northeast Broadcast, LLC.

Richard B. Armfield, Jr.

Richard B. Armfield, Jr. is President and a Director of SJL of California, Inc. Mr. Armfield is also a Vice President, a Director and owns a 10.79% interest of SJL of Communications, Inc. Mr. Armfield is also a limited partner with a 9.0% equity interest in SJL Communications, L.P.
