The Common will receive distributions only after the Preferred has received its invested capital plus a preferred return. The Series B Preferred will receive distributions only after the Series A Preferred has received its invested capital. The Preferred will be held in the following percentages (with the series held in parentheses): Waimanalo Holdings II, LLC, 65.20% (Series A Preferred); Lilly Broadcast Group, LLC, 22.35% (Series A Preferred); Brian W. McNeill, Eileen Toti and Chris Dias, collectively, 7.45% (Series A Preferred); Alta SJL TV, LLC, 5.00% (Series B). The Common will be held in the following percentages (with the class held in parentheses): Waimanalo Holdings II, LLC, 51.47% (Class A Common); Lilly Broadcast Group, LLC, 37.65% (17.65% in Class A Common and 20.00% in Class C Common); Brian W. McNeill, Eileen Toti and Chris Dias, collectively, 5.88% (Class A Common); and Alta SJL TV, LLC, 5.00% (Class B Common).
