

Modification of License for Noncommercial Educational Status
Station WTQX(FM), Boothbay Harbor, ME, Facility ID 4090

Explanation of Application. Maine Public Broadcasting Corporation (“Maine Public”) submits this application to modify the license for Station WTQX(FM) from commercial to noncommercial educational status, effective upon the consummation of the assignment of station WTQX(FM) to Maine Public. This application is submitted in connection with the pending assignment of license application for WTQX(FM), from Blueberry Broadcasting, LLC (“Blueberry Broadcasting”) to Maine Public, in FCC File No. BALH-20170728AEN, and pursuant to Section 73.3517(a) (Contingent Applications) of the FCC’s Rules. Maine Public has received written authorization from Pine Tree to submit this application while the assignment application is pending (*see attached*).

This application also includes a request for waiver of the main studio location requirements of the FCC’s Rules to allow for operation of the station as a satellite of Maine Public’s co-owned noncommercial educational radio station WMEA(FM), Portland, Maine.

Previously Approved Educational Qualifications and Advancement of Educational Program. Maine Public Broadcasting Corporation (“Maine Public”) certifies that the Commission has previously granted broadcast applications that found this applicant qualified as a noncommercial educational (“NCE”) entity with a qualifying educational program. Maine Public will use WTQX(FM) to advance a program similar to that the FCC has found qualifying in connection with its other NCE-licensed radio stations.

As detailed in this application, Maine Public is the licensee of nine noncommercial educational FM radio stations (WMEW, Waterville, Maine; WMEA, Portland, Maine; WMED, Calais, Maine; WMEF, Fort Kent, Maine; WMEH, Bangor, Maine; WMEM, Presque Isle, Maine; WMEP, Camden, Maine; WFYB, Fryeburg, Maine; and WRMO, Milbridge, Maine) and is the licensee of five noncommercial educational television stations (WCBB, Augusta, Maine; WMEA-TV, Biddeford, Maine; WMEB-TV, Orono, Maine; WMED-TV, Calais, Maine; and WMEM-TV, Presque Isle, Maine).

The stated mission of Maine Public is to connect the people of Maine to each other and to the world through the open exchange of information, ideas and cultural content. As Maine’s premier, independent media resource, Maine Public creates exceptional opportunities for the communities it serves to engage with critical issues, compelling stories and quality entertainment. Maine Public was formed in 1992 through the merger of the educational radio and television stations provided by the University of Maine System and WCBB public television operated by Colby, Bates and Bowdoin Colleges. Maine Public is an independently owned and operated 501(c)(3) nonprofit organization with office and studio locations in Bangor, Lewiston and Portland, Maine.

As the long-time licensee of existing NCE radio stations, Maine Public has clearly demonstrated its commitment to, and capability of, providing educational broadcast programming. Maine Public will continue to ensure that high quality public radio is available to its existing and proposed service areas. Maine Public plans to continue to provide a wide range of cultural, news, public affairs, and noncommercial entertainment programming to address issues of interest and concern to residents of its listening areas.

PERMISSION TO FILE MINOR CHANGE APPLICATION
