This supplemental engineering statement has been prepared in support of the pending application¹ (FCC File No. BMPCDT-20080619AFS) for modification of construction permit on behalf of NVT Savannah Licensee, L.L.C., licensee of WJCL(TV), Savannah, Georgia. The purpose of this pending application is to maximize the WJCL-DT service area in accordance with the FCC Public Notice dated May 30, 2008.²

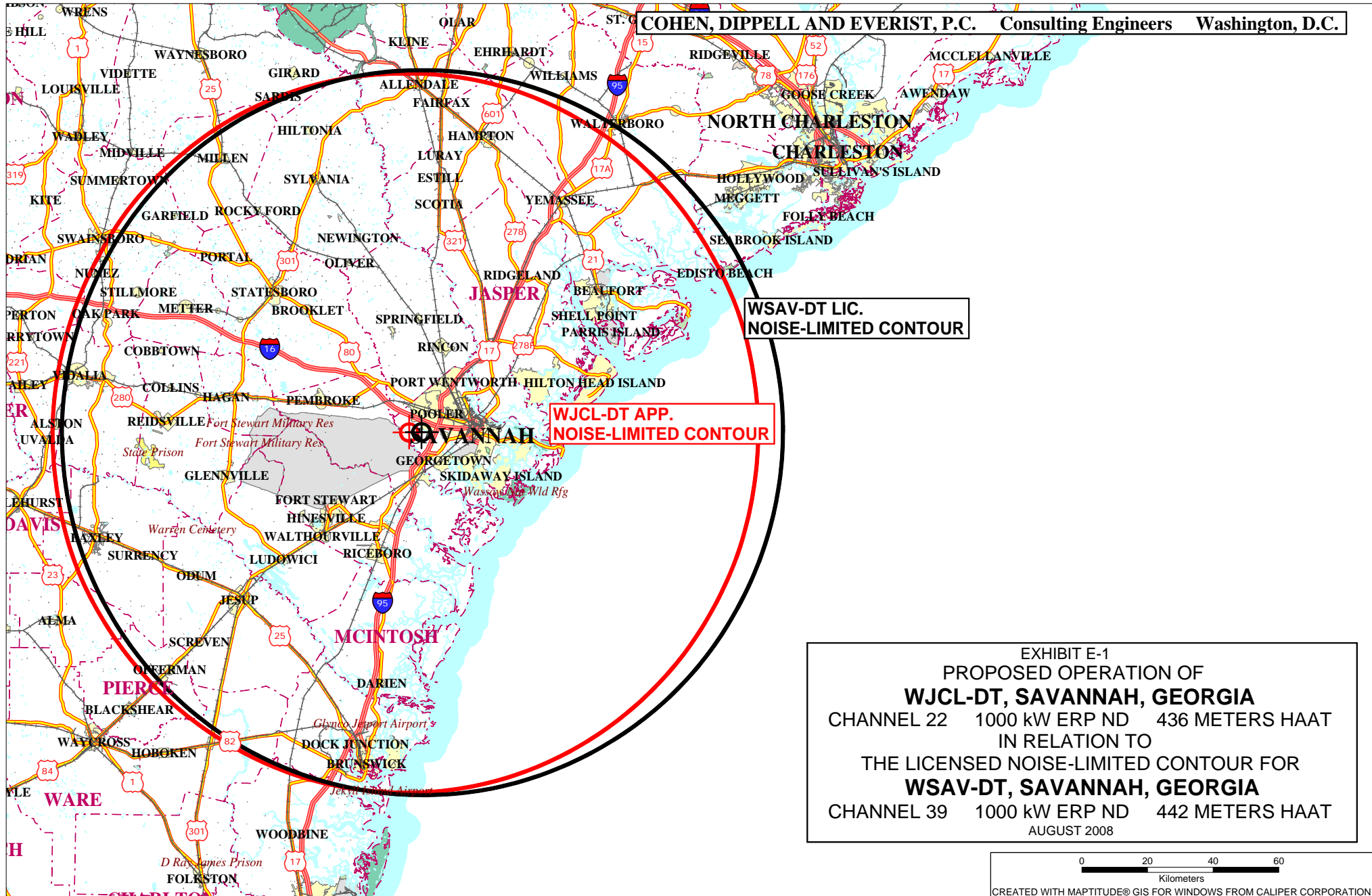
WJCL(TV) is licensed to operate on NTSC television Channel 22 with a maximum visual ERP of 3800 kW (directional) and an antenna height above average terrain (“HAAT”) of 436 meters (1430 feet). WJCL-DT has been allocated DTV Channel 22 with facilities of 166.17 kW (directional) ERP and 436 meters HAAT in the revised DTV Table of Allotments³ and is authorized to construct post-transition facilities of 85 kW directional and 436 meters HAAT (FCC File No. BPCDT-20080515ACT). WJCL-DT proposes to construct further post-transition DTV facilities with 1000 kW directional ERP and 436 meters HAAT in this pending application (FCC File No. BMPCDT-20080619AFS). The purpose of this engineering statement is in response to a FCC staff member’s informal request with reference to compliance with Section 73.622(f)(5) of the FCC Rules.

Section 73.622(f)(5) permits a station to increase its facilities to have a service area equal to or less than that already authorized in the market. Station WSAV-DT, licensed to Savannah, Georgia, Channel 39, operates with 1000 kW non-directional ERP and 442 meters HAAT. WSAV-DT possesses a slightly larger F(50,90) 41 dBu DTV noise-limited service area than that requested by WJCL-DT. The licensed WSAV-DT service area is predicted to encompass 834,328 persons and the proposed WJCL-DT service area is predicted to encompass 833,859 persons based on the contour method for predicting population within a noise-limited service area and 2000 U.S. census data. Attached is Exhibit E-1 which provides a service area comparison.


