BHC is a nonprofit corporation under Section 501(c)(3) of the Internal Revenue Code and is controlled by The First Presidency ("First Presidency") of The Church of Jesus Christ of Latter-day Saints (the "Church"), which consists of each succeeding President of the Church and counselors appointed by the President. The President of the Church is Gordon B. Hinckley. The Board of Directors (Trustees) of BHC is appointed (and subject to removal) by the First Presidency.

The First Presidency also controls the DMC Reserve Trust, which is the sole shareholder of Deseret Management Corporation ("DMC"), a Utah corporation. DMC is the sole shareholder of Deseret News Publishing Company, a Utah corporation and publisher of the Deseret Morning News, a daily newspaper published in Salt Lake City, Utah.

DMC is also the sole shareholder of Bonneville International Corporation (“BIC”), a Utah corporation. Pursuant to an Amended and Restated License Agreement, a copy of which is on file with the Commission, BIC manages and operates the stations licensed to BHC.

The Church controls Brigham Young University, Provo, Utah, which is the licensee of noncommercial educational stations KBYU-FM (Facility ID #6825) and KBYU-TV (Facility ID #6823), Provo, Utah. The Church also controls Brigham Young University – Idaho, which is the licensee of noncommercial educational radio stations KBYI(FM) (Facility ID #56345) and KBYR-FM (Facility ID #56352), Rexburg, Idaho.
