Dear Mr. Withers:

This is in reference to the request filed April 12, 2010, on behalf of Pacific Broadcasting of Missouri LLC (PBM). PBM requests extension of the special temporary authority (STA) granted on October 13, 2009, to operate Station KTKY with temporary facilities.¹ In support of the request, PBM states that construction of the facilities authorized by Construction Permit BPH-20000613AAF is not yet complete.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has made progress toward restoration of licensed operation, but additional time is required for completing the work. Thus, extension of STA is

¹ KTKY is licensed to Refugio, Texas, for operation on Channel 291C3 (106.1 MHz) with effective radiated power (ERP) of 25 kilowatts (H&V) and antenna height above average terrain (HAAT) of 100 meters. Construction Permit BPH-20000613AAF authorizes relocation of the transmitter, a change in the community of license to Taft, Texas, an upgrade to Channel 293C2 (106.5 MHz), an increase in ERP to 50 kilowatts (H&V) and an increase in the HAAT to 136 meters. The permit expires December 18, 2011.

warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KTKY may continue to operate with the following facilities:

Effective radiated power:	0.15 kilowatt (H&V)
Antenna height:	
above ground:	12 meters
above mean sea level:	30 meters
above average terrain:	14 meters

PBM must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **November 14, 2010**.
