This Application seeks consent to the assignment of the broadcast authorizations for WGNT(TV), Portsmouth, Virginia, from The CW Television Stations, Inc. to Local TV Virginia License, LLC ("LTV Virginia"), an indirect subsidiary of Local TV, LLC. Nielsen Media Research assigns WGNT(TV) to the Norfolk-Portsmouth Designated Market Area. LTV is the licensee of WTKR(TV), Norfolk, Virginia, which is also assigned to the Norfolk-Portsmouth DMA.

Multiple Ownership

Section 73.3555(b) of the Commission's rules permits common ownership of two television stations in the same Nielsen DMA if:

- (1) at least eight independently owned and operating commercial and/or noncommercial television stations, the Grade B contours of which overlap with the Grade B contour of at least one station in the proposed combination, will remain post-merger in the DMA; and
- (2) at least one of the stations to be commonly owned is not among the top four stations in the market, ranked according to audience share by Nielsen or a comparable rating service at the time the application is filed.

The proposed transaction complies with Section 73.3555(b). First, nine independently owned commercial and noncommercial television stations with overlapping signals will remain in the Norfolk-Portsmouth DMA following consummation of the proposed transaction, as reflected below:

Second, the most recent Nielsen ratings publication identifies WTKR(TV) as one of the top four rated stations in the DMA. The same publication also identifies WGNT(TV) as the fifth rated station in the DMA. Consequently, this transaction complies with the Commission's television duopoly rule.

Mr. Lawrence also serves as Chairman of KTRS-AM, LLC, which is the sole Member of the station's licensee. Mr. Lawrence also serves as Chairman and Manager of St. Louis Sports Radio, LLC, which is the sole Member of KTRS-AM, LLC. Mr. Lawrence also serves as President and a Director of CR Holdings, LLC, which holds a fifty percent interest in St. Louis Sports Radio, LLC. In addition, Mr. Lawrence also holds a 7.5 percent voting interest in CR Holdings, LLC. Mr. Lawrence's interest in this single AM station and his interest in KTVI(TV) and KPLR(TV), St. Louis, Missouri, complies with Section 73.3555(c)(2).
