SEMM Foundation was incorporated as a non-profit organization on April 8, 2013 in the State of Ohio. Relative to **Section III, 1a**, prior to our incorporation as a non-profit, the company began its operations in April, 2010 and immediately developed, and continues to maintain a strong community presence. Our organization has been physically headquartered, has had a campus and 100 percent of our Board Members reside within 16.1 kilometers or 10 miles of the proposed studio and proposed antenna site.

Our **community presence** and commitment can be evidenced by our creation and implementation of a program in September 2010 (Our Give Back and Pay Forward Music Arts Initiative) to provide free private music lessons to needy and talented Columbus City School children. Without any funding in the form of grants or donations, free private music lessons have been provided to over 200 students from more than 13 separate schools, with each student receiving 3 months or 12 individual, weekly 1/2 hour lessons. SEMM Foundation provides private and group instrumental and vocal music lessons to students of all ages in Columbus and Central Ohio. Our Academy has become a leading private pre-collegiate music school specializing in high quality music education and professional music performance. We offer a variety of programs to all students, in all disciplines of music, for all ages, levels and styles of music.

Our multilingual faculty of degreed and professional instructors with national and international credentials, are committed to helping students grow and experience the joy and pleasure of music, music production and performance. To meet the cultural and linguistic demands of the students, in addition to English, the Academy's teachers can converse with students in Spanish, French and German.

Through the use of radio, community cultural and social events and services, as well as music education in the form of recitals and other student produced concerts and similar programming will be offered if SEMM Foundation is successful in its quest to receive a station license. In support of this and related **Section III, 2 and 4**, we've offered a sample proposed programming schedule in the form of **Exhibit 5** as an attachment to our application.

Our faculty, in addition to being accomplished performers and composers, are musicians and educators dedicated to the art of teaching. AMENDED AND RESTATED

**ARTICLES OF INCORPORATION
OF
SAX ENTERTAINMENT MUSIC AND MEDIA FOUNDATION**

The undersigned, desiring to form a nonprofit corporation under Chapter 1702 of the Ohio Revised Code, does hereby certify:

WHEREAS, the Incorporator filed the original Articles of Incorporation with the Ohio Secretary of State on April 8, 2013, and Incorporator hereby amends and restates the original Articles of Incorporation as follows:

FIRST: The name of the Corporation shall be SAX ENTERTAINMENT MUSIC AND MEDIA FOUNDATION, d.b.a. (SEMM FOUNDATION), hereinafter referred to as "Corporation".

SECOND: The place in Ohio where the principal office of the Corporation is to be located in the City of Columbus, Franklin County, Ohio.

THIRD: The purposes for which the Corporation is formed are exclusively for charitable, educational and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or corresponding provisions of any future United States internal revenue law) (the "Code"), including the promotion of education through the medium and techniques of radio broadcasting and musical training & education. In furtherance of this purpose, the Corporation may develop, produce and provide programming to broadcast stations including radio, cable and television and operate a noncommercial FM radio station to provide radio broadcasting, support and educational information to the community and the support of musicians, events, music education, rehearsals, recordings, and the music that has been overlooked or under represented by other radio medium.

The Corporation may cooperate with other non-profit organizations, governments, public agencies, public and private educational organizations in furtherance of these purposes. The promotion of education may be accomplished in conjunction with activities that are related to music, sports, entertainment, broadcasting, news coverage and public affairs.

The Corporation requires this paragraph and the following three radio station ownership governing paragraphs be maintained in perpetuity within the governing documents. Further, the Corporation requires this Corporation to meet and maintain all FCC rules regarding LPFM ownership, and that this Corporation, as licensee of a LPFM station will take the immediate steps necessary to remain in compliance with all FCC rules for LPFM ownership.

The Corporation will seek to own a radio broadcast station, which will produce and provide programming 24 hours a day, 7 days a week produced by this Corporation. We commit to no less than 8 hours of original programming produced 7 days a week. Further, this Corporation will be involved in the production and dispersion of educational and religious media, and the transaction of any or all lawful business for which may be conducted by such enterprise.

The Corporation will provide a publicly accessible main studio, and corporate headquarters, with local program origination capability, staffed with volunteers working 20 or more hours per week between 7 a.m. – 10 p.m. (at a minimum), and within 10 miles of the proposed transmitting antenna site.

The Corporation will require 75% of the total board membership (directors) to be held by members that reside within 10 miles of the proposed transmitting antenna site.

FOURTH: The Corporation is formed exclusively for purposes for which a corporation may be formed under the Ohio Nonprofit Corporation Law and not for pecuniary profit or financial gain. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its trustees, officers or other private persons or organizations, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article THIRD hereof. The Corporation shall have the power to do any and all lawful acts and things and to engage in any and all lawful activities which may be necessary, useful, suitable, desirable or proper for the furtherance, accomplishment or attainment of any and or all of the purposes for which the Corporation is organized, and to aid or assist other corporations whose activities are such as to further, accomplish, foster or attain any such purposes. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation (except to the extent provided in Code Section 501(h)), and the Corporation shall not participate in, or intervene in (including the publication or distribution of statements), any political campaign on behalf of (or in opposition to) any candidate for public office. Notwithstanding any provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on: (a) by a corporation exempt from federal income tax as an organization described in Code Section 501(c)(3); or (b) by a corporation, contributions to which are deductible under Code Sections 170(c), 2055(a) and 2522(a).

FIFTH: Upon the dissolution of the Corporation, the Board of Trustees shall, after paying or making provision for the payment of all liabilities of the Corporation, distribute the assets of the

Corporation exclusively for one or more exempt purposes within the meaning of Code Section 501(c)(3), or to the federal government or a state or local government for a public purpose. Any assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes, as said Court shall determine to best accomplish the exempt purposes of the Corporation.

SEVENTH: These Articles of Incorporation may be amended from time to time, in whole or in part, by a two-thirds (2/3) majority vote of the whole number of Trustees.



ORIGINAL APPOINTMENT OF STATUTORY AGENT


