

Exhibit 11 - Ownership Information

The purpose of this Amendment is to demonstrate that there are no non-attributable interest holders in New Age Media of Pennsylvania License, LLC (the “Applicant”) and to notify the FCC that Frank M. Henry’s interest in the Applicant is now held through Dallas Media, LLC, a new, domestic limited liability company.

The Application as originally filed presented each attributable interest holder’s voting interest in the Applicant and the percentage of total assets that each attributable interest holder held in the Applicant. In order to more clearly demonstrate that there are no non-attributable ownership interests in the Applicant, this Amendment sets forth the ownership information for each entity in the Applicant’s chain of ownership.

Except with respect to the interest of Frank M. Henry, there has been no change in the ownership of the Applicant since the filing of the Application. The address and citizenship of each previously identified attributable interest holder is unchanged and is therefore not restated herein.

The sole member of the Applicant is New Age Media of Pennsylvania, LLC (“New Age Pennsylvania”), which holds 100% of the votes and 100% of the total assets of the Applicant. The sole member and owner of 100% of the votes and 100% of the total assets of New Age Pennsylvania is CP Media, LLC (“CP Media”).

The Members of CP Media are Dallas Media, LLC (holding 33.64% of votes and 33.64% of the total assets of CP Media), Sedgwick Media, LLC (holding 65% of the votes and 65% of the total assets of CP Media) and Michael Yanuzzi (holding 1.36% of the votes and 1.36% of the total assets of CP Media).

Sedgwick Media, LLC has two classes of members: voting and non-voting. The voting membership interests are held by John Parente, who holds 51% of the votes of Sedgwick Media, LLC, and Charles E. and Mary M. Parente, who hold the remaining 49% of the votes of Sedgwick Media, LLC as co-Members. John Parente also holds 14.08% of the total assets of Sedgwick Media, LLC, while Charles E. Parente holds 7.04% of the total assets of Sedgwick Media, LLC.

The remaining Members of Sedgwick Media, LLC hold non-voting membership interests. Their interests (as a percentage of the total assets of Sedgwick Media, LLC) are set forth below.
