

### **OTHER AUTHORIZATIONS**

Mission Broadcasting, Inc. ("Mission") is the licensee of television stations WYOU, Scranton, Pennsylvania, Facility No. 17010, WFXP, Erie, Pennsylvania, Facility No. 19707, KJTL, Wichita Falls, Texas, Facility No. 7675, and KODE-TV, Joplin, Missouri, Facility No. 18283. Mission also is the licensee of low power television station KJBO-LP, Wichita Falls, Texas, Facility No. 7670 and television translator stations W19AR, Clarks Summit, Pennsylvania, Facility Number 17007; W26AT, Williamsport, Pennsylvania, Facility Number 16994; W54AV, Mansfield, Pennsylvania, Facility Number 17002; W55AG, Williamsport, Pennsylvania, Facility Number 17004; W60AH, Stroudsburg, Pennsylvania, Facility Number 16989; W66AI, Pottsville, Pennsylvania, Facility Number 17009, K47DK, Grandfield, Oklahoma, Facility No. 7673 and K53DS, Lawton, Oklahoma, Facility No. 7672.

Mission also is the assignee in a pro forma application for consent to the assignment of licenses of television broadcast station KCIT, Amarillo, Texas, Facility No. 3372; low power television station KCPN-LP, Amarillo, Texas, Facility No. 7739; and television translator stations K30DZ, San Jon, New Mexico, Facility No. 51468; K35CG, Bovina, Texas, Facility No. 33717; K47DH, Clovis, New Mexico, Facility No. 33718; and K50FK, Amarillo, Texas, Facility No. 7736. The FCC has granted consent for Mission's acquisition of these stations; however, the transaction has not yet closed.

David S. Smith, the Director, President and Treasurer of Mission also is the Director, President, Treasurer and 100 percent shareholder of the following corporations:

1. Mission Broadcasting III, Inc. ("Mission III"). Mission III submitted an application to the Commission for a construction permit for construction of a new station on channel 4 in Utica, New York, on July 24, 1996. The application was not accepted for filing by the Commission and was returned pursuant to the Commission's letter of September 12, 1996 stating that Utica, New York is within the "freeze" area imposed by the Commission. Mission III submitted a petition for reconsideration on October 15, 1996, which remains pending, and an amendment to the application on July 17, 2000. (No facility number has been assigned.)
2. Kenos Broadcasting II, Inc. ("Kenos II"). Kenos II is the transferee in a pending application to acquire television broadcast station KHMT, Hardin, Montana, Facility No. 47670 (File No. BALCT-20030519AET).
3. Mission Broadcasting of Amarillo, Inc. ("Mission Amarillo"), the parent of Mission Broadcasting of Amarillo License, Inc. ("Mission License"). Mission License is the assignor in the above-referenced pro forma application for consent to the assignment of television broadcast station KCIT, Amarillo, Texas, low power television station KCPN-LP, Amarillo, Texas, and their associated translator stations to Mission.
