Salem Communications Corporation proposes common ownership of four Portland area radio stations: KAST 92.9 FM, Astoria, KFIS 104.1 FM, Scappoose, KPDQFM 93.7 FM, Portland and KPDQ 800 AM, Portland.

This multiple ownership study is to ensure compliance with the Code of Federal Regulations Chapter 47, Part 73.3555 that outlines the conditions under which one licensee may own radio stations in a common market.

Exhibit 1 is a map showing the principal community contours of the four Portland stations under study as licensed. KAST's principal community contour does not overlap the other three Salem stations under study as all are licensed today.

After the changes are implemented that are envisioned in the application for construction permit FCC file number BPH20040824ABE, KAST will become part of the Portland market. This permit was filed in accordance with the FCC's Report and Order in MB Docket No. 02-136, dated July 7, 2004, changing the community of license from Astoria, OR to Gladstone, OR.

47 CFR 73.3555 (a)(1) (i) says "In a radio market with 45 or more full-power, commercial and noncommercial radio stations, not more than 8 commercial radio stations in total and not more than 5 commercial stations in the same service (AM or FM)."

Exhibit 2 is the FCC Geographic Market Definition for Portland. This exhibit shows that there are 55 stations in the Portland market.


Therefore, ownership of KAST FM, KFIS FM, KPDQ Fm and KPDQ AM is in accordance with the Commission's multiple ownership rules. There are no parties

involved in this proposed acquisition that have any interest in any radio stations other than those listed above, in the Portland market.
