Changes in Interest

The majority, controlling owner of Rocky Mountain Broadcasting Company (“Rocky Mountain”), the permittee of commercial digital television station KMTF (TV), Channel 29, Helena, Montana, is Uhlmann/Latshaw Broadcasting, LLC (“Uhlmann/Latshaw”), whose equal members are The Uhlmann Company (“Uhlman Company”) and Latshaw Enterprises, Inc. (“Latshaw Enterprises”)¹. This transfer of control seeks FCC approval for Uhlmann Company to purchase all of the membership interests in Uhlmann/Latshaw owned by Latshaw Enterprises, such that Uhlmann Company would own 100% of Uhlmann/Latshaw, and for various other prior transactions, described below. Uhlmann Company’s acquisition of the Latshaw Enterprises interest is memorialized in the August 23, 2012 Purchase and Sale of Membership Interest Agreement (“August 23, 2012 Agreement”), between Uhlmann Company and Latshaw Enterprises, a copy of which is included in this application at Exhibit 5.

Detailed information of the pre- and post-transfer attributable interest holders with respect to the buyout of Latshaw Enterprises is set forth in the chart at the end of this exhibit. First, however, is an explanation of material prior transactions occurring between 2007 and 2012 relating to the ownership of Latshaw Enterprises and Uhlmann Company.

As to Latshaw Enterprises, the changes between 2007 and 2012 involved The John Latshaw Trust Dated January 22, 1993, (“Latshaw Trust”) a recent 45% equity and 64% voting shareholder of Latshaw Enterprises, with John Latshaw as the settlor and initial trustee, and were related to John Latshaw’s ill health and subsequent death. Then in October of 2013, Latshaw Enterprises initiated dissolution proceedings. Changes as to the Latshaw Trust began On July 30, 2007, when the Trust was amended to add its first co-trustee, Country Club Trust Company (“Country Club”). On November 29, 2009, the Trust was further amended to designate a Business Advisory Board responsible for making decisions as to the Trust’s shares of Latshaw Enterprises. This Board initially consisted of John Latshaw, Country Club Trust Company, and Latshaw Enterprises President and Director Michael Bukaty. In March of 2010, John Latshaw was declared incapacitated, and on July 10, 2011 he passed away. His incapacitation resulted in his membership on the Advisory Board being transferred jointly to his two daughters, Elizabeth and Constance Latshaw, who were also beneficiaries of The John Latshaw Trust. On July 13, 2012, the Business Advisory Board ceased to exist, returning all shareholder decision-making authority to Country Club as trustee. The Plan of Dissolution of Latshaw Enterprises was approved by the Shareholders and Board of Directors on September 20, 2013, and transferred authority for winding up the affairs of the corporation to the Board. Latshaw Enterprises filed its Certificate of Dissolution with the State of Delaware on October 1, 2013. Item 1, below, gives transferor and transferee information for each of these five transfer events.

As to Uhlmann Company, certain prior transactions were triggered by the August 21, 2009 death of John W. Uhlmann and involved the John W. Uhlmann Trust A Under Trust Indenture dated March 23, 1989, a current 0% equity and voting shareholder of the Uhlmann Company, with John W. Uhlmann as the settlor and initial trustee. Patricia W. Uhlmann, John Uhlmann's widow, was the initial trustee following her husband's death, and on June 1, 2011 she resigned in favor of Jon A. Blongewicz, Esq. On August 31, 2011, at the end of a two-year period following Mr. Uhlmann's death, the qualification of the Trust to hold shares in Uhlmann Company ceased, resulting in the automatic redemption of those shares. (The Kansas State Court approval of this redemption is attached at Exhibit 6.) Item 2, below, gives transferor and transferee information for each of these three events.
