**NATURE AND EDUCATIONAL PURPOSES OF APPLICANT**

**Non-Profit and Educational Nature**

El Sembrador Ministries (ESNE) hereby certifies that it will operate KLO(AM), 1430 kHz, Ogden, Utah<sup>1</sup>, in a manner consistent with Section 73.503 of the Commission's Rules. The applicant is a California non-profit corporation which has been established for religious, educational and charitable reasons as well as such other purposes as may be permissible for a not for profit corporation under the laws of the State of California.

The FCC has previously found ESNE to be eligible to hold the licenses for six broadcast stations as a non-commercial, educational broadcaster: KHPY(AM), Moreno Valley, California, File No. BML-20130516AOT, granted September 18, 2013; KRXA(AM), Carmel Valley, California, File No. BML-20130516AOS, granted May 23, 2014; KDDF(FM), Mecca, California, File No. BALED-20151103AYX, granted February 8, 2016; KTYM(AM), Inglewood, California, File No. BML-20150918ACQ, granted June 29, 2016; KURS(AM), San

Diego, California, File No. BML-20161201AGV, granted March 27, 2017; and KENT(AM), Enterprise, Nevada, File No. BMML-20181203ACB, granted September 18, 2019. El Sembrador Ministries will operate KLO in the same manner that it operates KTYM, KHPY, KDDF, KRXA and KENT.

**Furtherance of Educational Objectives**

In *Columbia Bible College Broadcasting Co.*, 6 FCC Rcd 516 (1991), at paragraphs 9 and 10, the Commission stated that religiously-oriented applicants can meet the eligibility standards set forth in Section 73.503 of the Commission's Rules, where the applicant (1) proposes an overall educational program and (2) its proposed programming furthers its educational objectives.

The applicant is eligible pursuant to Section 73.503 to be a non-commercial licensee of the station covered by this application, because the applicant proposes programming which constitutes an overall educational program and the programming furthers the organization's educational objectives, which are to teach the gospel of Jesus Christ in the Spanish language. In this case, the applicant intends to broadcast programs to further the educational purposes of El Sembrador, which are (1) the

teaching of the Roman Catholic faith in the Spanish language and (2) educating and informing the public about issues related to the Roman Catholic Church among Spanish speaking persons in the United States as well as up and down North, Central and South America.

We intend to broadcast substantially the same program schedule as is currently heard on our six existing non-commercial educational licensed radio stations: KTYM, which serves the Los Angeles metropolitan area; KHPY, which serves the San Bernardino-Riverside market; KDDE, which serves the Indio-Palm Springs market; KRXA, which serves the Monterey-Salinas market; KURS, which serves the San Diego metropolitan area; and KENT, which serves the Las Vegas metropolitan area.

In sum, it is our objective to use the proposed radio station to provide a valuable educational resource for the residents of Enterprise, Nevada and the surrounding Las Vegas metropolitan area in the public interest, convenience and necessity.
