**Article 5 - Purpose**

The corporation is organized for the following purpose or purposes:

**This Corporation is organized pursuant to the Texas Business Organizations Code. The purposes for which the Corporation is organized are exclusively charitable within the meaning of the Internal Revenue Service Code, Section 501 (c) (3),**

and the Texas Tax Code, Section 11.18, and consist of the following:

(a) To establish and operate an FM and/or AM broadcast and Internet radio station in order to provide news, entertainment, educational programming, including public and emergency information, and educate interested persons in radio related technical and communication skills.

**Supplemental Provisions / Information**

**ARTICLE 6 - Dissolution/ Termination - Upon the dissolution of the organization, assets shall be distributed for one or more purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.**
