**Re: Request for Special Temporary Authority to Operate at Variance  
KLJK(FM), Weiner, Arkansas (FIN: 52903)**

Dear Ms. Dortch:

On behalf of Educational Media Foundation ("EMF"), the licensee of FM radio station KLJK(FM), Weiner, Arkansas, and pursuant to Section 73.1635 of the Commission's Rules, this letter is to notify the Commission and request Special Temporary Authority (an "STA") to allow EMF to operate KLJK with the parameters set forth herein.

The KLJK construction permit, FCC File No. BMPED-20091203AIH, was granted on March 13, 2009 and expires on March 13, 2011. On March 13, 2011, the KLJK facilities were fully constructed and KLJK commenced operation but, due to a miscommunication, the transmit antenna was mounted approximately 9 meters lower than the elevation specified in the construction permit. The issue was discovered too late in the construction process so that a custom antenna bracket necessary to mount the antenna at the authorized height could not be made available. EMF has confirmed that the 70 dBu contour coverage of the facility is slightly reduced, but still completely encompasses the city of license. Additionally, the station is operating with the authorized effective radiated power of 6 kilowatts and does not produce radiofrequency fields in excess of FCC guidelines.

EMF is working to quickly procure the customized antenna bracket and correct the facility's antenna elevation. In the interim, EMF respectfully requests an STA to allow KLJK to operate with its antenna height as built. To the extent necessary, EMF also respectfully requests that the Commission toll or waive the construction period set forth in the KJLK construction permit. EMF will promptly notify the Commission and complete construction of KLJK at the authorized elevation.

Grant of this STA is in the public interest because it will allow the station to provide this new service to the listeners at Weiner, Arkansas. The station is licenseable at the current height as it fully covers the proposed city of license with a city-grade signal and otherwise meets FCC rules. Full compliance with the terms of the construction permit should be achieved shortly.
