Under the Section 803 of the Not-For-Profit Corporation Law whereby:

We, the undersigned, being the president and secretary of said corporation, for the purpose of amending said Certificate of Incorporation to change the corporate name, certify:

1. The name of the corporation is the Dominican Monastery of the Perpetual Rosary of Elmira, New York.

2. The corporation was organized under the Membership Corporation Law by Certificate of Incorporation. The Corporation was incorporated on September 26, 1944.

3. The corporation is a corporation as defined in Not-For-Profit Corporation Law, Section 102, subdivision (a) (5) and is a Type B corporation under Section 201 of said law.

4. The name of the corporation is henceforth changed to the Dominican Monastery of Mary the Queen, which is the sole change to the original Certificate of Incorporation.

5. Such amendment was authorized by the unanimous vote

of the Board of Directors.

6. The corporation designates the Secretary of State as its agent upon whom process against it may be served and the post office address to which the Secretary of State shall mail a copy of any process against the corporation served on him is: 1310 West Church Street, Elmira, New York 14905.
