Dear Mr. Altman:

This is in reference to the request filed on August 16, 2017. CRS requests a further extension of the STA granted on February 6, 2014, to continue ND operation at night pending further action on the application BP-20170818AAY.<sup>1</sup> In support of the request, we noted that the application remains pending before the Commission at this time.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of STA IS HEREBY GRANTED, and CRS may continue to operate ND at night using a maximum power of 0.023 kW as specified in BP-

<sup>1</sup> WHGM(AM) is licensed for operation on 1330 kHz with 5 kW day (ND), and 0.5 kW night (DA), and BP-20170818AAY proposed nighttime ND operation using the daytime tower at 0.023 kW.

20170818AAY (with no change to the licensed 5 kW daytime ND operation). CRS must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **March 20, 2017**.
