Changes in Interest as a Result of Transfer

Rocky Mountain Broadcasting Company (“Rocky Mountain”), the permittee of commercial digital television station KMTF (TV), Channel 29, Helena, Montana, is 51% owned by Uhlmann/Latshaw Broadcasting, LLC (“Uhlmann/Latshaw”), and 49% owned by Meridian Communications of Montana, Inc. (“Meridian”). The proposal for transfer of control calls for Meridian to purchase all of the stock of Rocky Mountain owned by Uhlmann/Latshaw (51 shares) such that Meridian would come to own all 100 (100%) of the issued and outstanding shares of Rocky Mountain. This transfer of control takes place pursuant to the March 3, 1997 Stock Purchase Agreement, as amended August 30, 2006, by and among Uhlmann/Latshaw, Meridian and Rocky Mountain, a copy of which is on file with the Commission and included herewith.

Other than Suzanne E. Rogers (currently a vice president of operations and a director of Rocky Mountain) and Brian J. Plant (currently the assistant vice president of operations of Rocky Mountain), the current attributable interest holders of Rocky Mountain, i.e., Uhlmann/Latshaw and its attributable interest holders, will retain no attributable interests in Rocky Mountain upon the consummation of the transfer of control. The Uhlmann/Latshaw attributable interest holders are set forth on the following two pages. The post-transfer attributable interest holders are set forth thereafter.
