

Media Interests of Immediate Family Members

1. As described below, the proposed assignment does not present an issue under the Commission's policies relating to media interests of immediate family members. Barbara Laurence and Lynn Welshman are married, and Barbara Laurence and Paul Libovitz are siblings. Mr. Welshman and Mr. Libovitz have an interest in KBNB-LP, which is located in the same DMA as KTRG-TV. These interests ultimate do not present an issue because the Commission's multiple ownership rules do not prohibit common ownership of a full-power TV station and an LPTV station in the same market. See 47 C.F.R. § 73.3555. Nevertheless, for the convenience of FCC staff, the media interests of Lynn Welshman and Paul Libovitz are set forth below.
2. Lynn Welshman, 10155 Collins Avenue, Suite 1505, Bal Harbour, FL 33154, a U.S. Citizen, holds the following interests:
 - a. Member and Director of Cranston II, LLC ("Cranston II") as well as a Member, President and Director of Welshman 1210, LLC, a Florida limited liability company ("Welshman 1210"). Welshman 1210 is also a Member of Cranston II. Mr. Welshman holds a 76% ownership interest in Welshman 1210, and therefore, he holds 49.812% of the common unit votes, and 7% of the preferred unit votes, in Cranston II.
 - b. Board Member and Vice President of Cranston, LLC ("Cranston"). Mr. Welshman holds a 69% membership interest in Cranston.
 - c. Vice President and Member of LATV Partners, LLC ("LATV Partners"). Mr. Welshman holds 73.5% of the Membership Interest of LATV Partners.
 - d. Vice President and Member of Canal Plus, LLC ("Canal Plus"). Mr. Welshman holds a 77.5% ownership interest in Canal Plus.
3. Paul Libovitz, 605 Ives Dairy Road, Suite G-401, Miami Florida, 33179, a U.S. Citizen, holds the following interests:
 - a. Member, Secretary and Director of Cranston II as well as a Member, Secretary and Director of Welshman 1210. Welshman 1210 is also a Member of Cranston II. Mr. Libovitz holds a 24% ownership interest in Welshman 1210, and therefore, he holds approximately 16.72% of the common unit votes and 24% of the preferred unit votes of Cranston II.
 - b. Secretary and Member of Cranston. Mr. Libovitz holds an 11 % membership interest in Cranston.

- c. Holder of 100% of the Membership Interest in and sole manager of PMJ, LLC, a Delaware limited liability company; Assistant Secretary and a board member of LATV Partners. PMJ, LLC holds a 7% membership interest in LATV Partners.
 - d. Assistant Secretary and Member of Canal Plus, LLC. Mr. Libovitz holds a 5% ownership interest in Canal Plus.
4. The media interests of Cranston II, Cranston, LATV Partners and Canal Plus are set forth in Exhibit 13.
