Engineering Statement

The engineering exhibit consisting of this statement and the attached Figure 1 and 2 was prepared on behalf of Radio One Licenses, LLC, in connection with the upgrade application of station WFXC Durham, North Carolina. The ownership study demonstrates compliance with the radio ownership rules contained in 47 CFR 73.3555.

The Radio One stations of interest are:

1. WFXC Durham, NC 296C3, 7.5 KW, 151 M
2. WQOK South Boston, VA 248C1, 100 KW, 299 M
3. WFXK Tarboro, NC 282C1, 100 KW, 299 M
4. WNNL Fuquay-Varina, NC 280C3, 7.9 KW, 176 M

The 70 dBu (3.16 mV/m) contours for these FM stations are shown on Figure 1. The contours of WFXC, WQOK and WFXK overlap thereby forming one radio market. The contour of WNNL does not overlap the contours of the other stations and is therefore not part of this study.

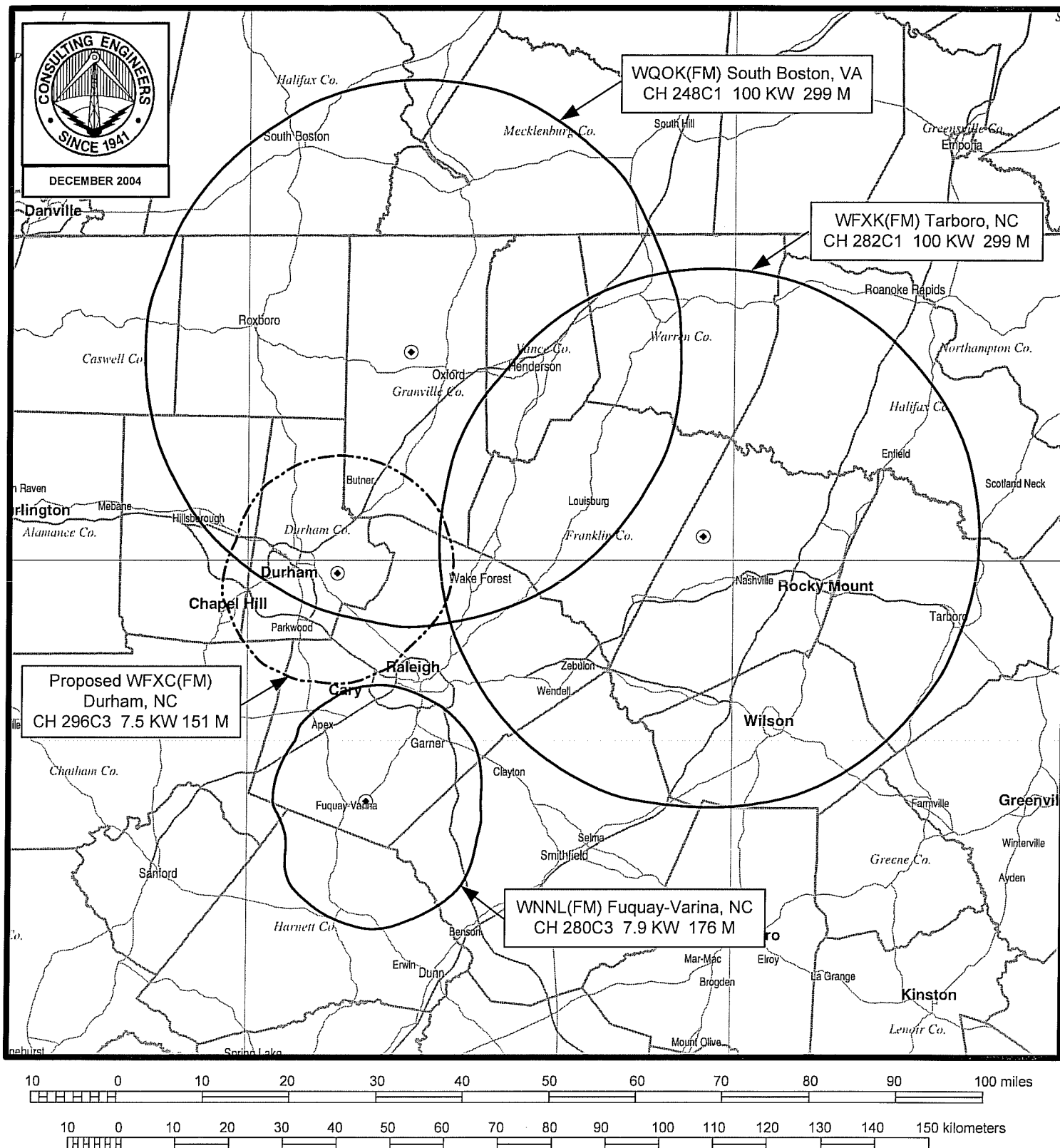
The transmitter sites of 18 FM stations and 21 AM stations are located within the contours of the three stations forming the radio market. All of these stations are within 92 kilometers of the three station overlap area. A tabulation of these stations is provided in Figure 2.

Based on this information, the change in coverage proposed by WFXC complies with the ownership rules of 47 CFR 73.3555.
