Dear Counsel:

This is in reference to the request filed July 8, 2013, on behalf of Calvary Chapel of Twin Falls ("CCTF"). CCTF requests special temporary authority ("STA") to operate station K206CF with reduced power. Between February 8, 2010 and June 20, 2013, K206CF operated at its maximum authorized ERP (0.034 kW) without complaint. On June 21, 2013, CCTF received complaints of interference from counsel for KSTX (FM), San Antonio, TX. CCTF requests authority to operate with reduced power (0.017 kW) while it assesses these complaints.

Section 73.1560(d), which governs reduced power operation, states:

In the event it becomes technically impossible to operate at authorized power, a broadcast station may operate at reduced power for a period of not more than 30 days without specific authority from the FCC. If operation at reduced power will exceed 10 consecutive days, notification must be made to the FCC in Washington, DC, Attention: Audio Division (radio) or Video Division (television), Media Bureau, not later than the 10th day of the lower power operation. In the event that normal power is restored within the 30 day period, the licensee must notify the FCC of the date that normal operation was restored. If causes beyond the control of the licensee prevent restoration of the authorized power within 30 days, a request for Special Temporary Authority (see Section 73.1635) must be made to the FCC in Washington, DC for additional time as may be necessary.

Our review indicates that the request complies with Section 73.1560(d).


Accordingly, the request for STA IS HEREBY GRANTED. Station K206CF may continue to operate with reduced power.<sup>1</sup> CCTF must notify the Commission when licensed operation is restored. CCTF must use whatever means are necessary to protect workers and the public from radiofrequency exposure in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.

<sup>1</sup> This reduced power STA does not preclude K206CF from returning to its licensed operation at 0.034 kW ERP, or operation at an intermediate power level, for the purpose of determining that power level's effect on received interference.

**This authority expires on January 5, 2014.**
