

PARTIES TO APPLICATION AND OTHER AUTHORIZATIONS

The Assignor, Communications Capital Company II of Georgia, LLC (“CCCIIGA”), is a Delaware limited liability company whose equity members are Communications Capital Company II, LLC (“CCCII”)(99%), a Delaware limited liability company, and Communications Capital Managers, LLC (“CCM”), a Delaware limited liability company (1% equity).

CCM has an 82.5% equity interest and membership in CCCII which, in turn, is the sole member and equity owner of CCCIIGA, licensee of FM Broadcast Station WSKX, Hinesville, Georgia, and Communications Capital Company II of Louisiana, LLC (“CCCILA”), licensee of FM Broadcast Stations KNBB (Facility I.D. No. 5065) and KXKZ (Facility I.D. No. 58273) and AM Broadcast Station KRUS (Facility I.D. No. 58272), Ruston, Louisiana. On October 25, 2001, the FCC granted consent (Application File No. BAL-20010829AAX) for CCM to acquire Station WSYL (AM) (Facility I.D. No. 58752), Sylvania, Georgia, from SAM-MAC Broadcasting Systems, Inc.; this transaction has not yet been consummated. On November 13, 2001, the FCC granted consent (Application File Nos. BAL-200010829AAU, BALH-20010829AAV and BALH-20010829AAW) to assign the licenses of, respectively, Stations WWNS (AM) (Facility I.D. No. 54804) and WMCD (FM) (Facility I.D. No. 54805), Statesboro, Georgia, and WZBX (FM) (Facility I.D. No. 60213), Sylvania, Georgia, from Radio Statesboro, Inc. to CCM; this transaction has not yet been consummated.

CCM has the following four equity members, each having a 25% equity interest: Hemlock Partners, LLC, of which the sole manager and equity member is R. Charles McLavy; McKinley Road Associates, LLC, of which the sole manager and equity member is Michael H. Oesterle; Yost Ventures, LLC, of which the sole manager and equity member is G. Woodward Stover, II; and Michael F. Starr. Set forth below are the other broadcast interests of Michael H. Oesterle, R. Charles McLavy, G. Woodward Stover, II, and Michael F. Starr:

Michael H. Oesterle: President, Secretary and Director of WinCom Communications, Inc., the general partner of WHFB Broadcast Associates Limited Partnership, licensee of Stations WHFB (Facility I.D. No. 72174) and WHFB-FM (Facility I.D. No. 72175), Benton Harbor, Michigan; Manager of CCM, Managing Director of CCCII and Managing Director and CEO of CCCIIGA and CCCILA (see above).

G. Woodward Stover, II: Chairman, CEO, Treasurer, Director and 100% owner of WinCom Communications, Inc., the general partner of WHFB Broadcast Associates Limited Partnership, licensee of Stations WHFB (Facility I.D. No. 72174) and WHFB-FM (Facility I.D. No. 72175), Benton Harbor, Michigan; and Managing Director of both CCM and CCCILA (see above).

Michael F. Starr: Manager and CEO and 50% equity member of Delta Starr Broadcasting, LLC, which, in turn, owns (98%) of La Terr Broadcasting Corporation, licensee of KTIB (AM) (Facility I.D. No. 36183), Thibodaux, Louisiana; Manager, CEO and 51% owner of Coastal

Broadcasting of LaFourche, LLC , licensee of KANE (AM) (Facility I.D. No. 48452), New Iberia, Louisiana; and member of CCM (see above).

R. Charles McLavy: Managing Director of CCM and Managing Director of CCCIL, CCCIGA and CCCILA (see above).
