I am emailing in regard to KPGB 88.3 FM, Facility ID 91709.

This station is owned by Faith Baptist Church in Pryor, Montana.

I Ronnie Henderson, the Pastor of the Church for over 25 years and President of KPGB will be leaving the Church and Station and community due to partial retirement and to pursue a part time ministry of helps to other Reservation churches. All the volunteer members who helped with the operation of the station have either moved away, passed away due to the pandemic or are in poor health and unable to continue helping. Covid-19 hit our community on the Indian Reservation hard. The new Pastor and the Church membership have decided due to the lack of knowledge of the Radio operations and the amount of time it consumes that they would not be able to continue serving the community as it has been for the past 21 and 1/2 years, and that they just want to close the station and cease broadcasting. They have asked me to take care of this matter before my departure, I am asking from you for the exact procedures to get this taken care of, since I am not requesting a Special Temporary Authorization but a complete shut down. We would like to cease operations as of March 31, 2022 so I can move on to my new ministry.
