(“Alliance Media”) and has supplied approximately 59% of Alliance Media’s capital. Alliance Media is a non-managing member of Alliance Communications, L.L.C. (“Alliance Communications”). Alliance Media has supplied approximately 7% of Alliance Communications capital. SHOC also owns, through a wholly-owned subsidiary, an insulated limited partnership interest in Media Ventures, L.P. (“Media Ventures”) and has supplied approximately 13% of Media Ventures’ capital. Media Ventures holds a 12% interest in Alliance Communications. Through these two investments, SHOC has an interest of approximately 5% to 6% of the profits of Alliance Communications and an interest of approximately 7% in the capital of Alliance Communications. Alliance Communications holds an interest in cable systems in Arkansas, Ohio, Pennsylvania, Maryland, Missouri, Illinois, Virginia, West Virginia, Tennessee, Kentucky, and Indiana.
