

Franklin Communications, Inc. ("Franklin"), licensee of WSNY (FM), Columbus, OH, hereby notifies the Commission of the commencement of digital broadcasting using iBiquity Digital Corporation's HD Radio™ technology. Consistent with the Commission's Order on interim digital operations, *Digital Audio Broadcasting Systems and Their Impact on the Terrestrial Radio Broadcast Service*, 17 FCC Rcd 19990 (2002), Franklin hereby supplies the following information in support of this notification:

1. *Date.* Franklin plans to commence digital broadcasts on June 30, 2006.
2. *Certification of Facilities.* Franklin hereby certifies its facilities conform to the iBiquity Digital Corporation hybrid FM specifications.

Digital: 175 Watts (220 W ERP)


5. *Certification of ERP.* Franklin hereby certifies its analog effective radiated power will remain as authorized after commencement of digital operations.

6. *Radiation Exposure Certification.* Franklin hereby certifies that its interim digital operations will not cause human exposure to levels of radio frequency radiation in excess of Section 1.1310 of the Commission's rules and is therefore categorically excluded from environmental processing pursuant to Section 1.1306 (b).
