Nature of the Transaction

City College of New York ("CCNY"), licensee of Noncommercial Educational Class D FM Broadcast Station WHCR-FM, New York, New York (the "Station"), is a non-profit educational entity that operates the Station under the governance of the WHCR Advisory Board (the "Board"). CCNY hereby seeks the Commission's consent to a pro forma transfer of control inasmuch as the selection of several new board members would otherwise result in a situation wherein a majority of the Board would consist of persons who have not previously been passed upon by the Commission.

With respect to each and every member of the Board, no adverse filing has been made, nor has an adverse final action been taken, by any court or administrative body in a civil or criminal proceeding brought under the provisions of any law related to any of the following: any felony, mass media-related antitrust or unfair competition, fraudulent statements to a governmental unit, or discrimination. No member of the Board has an attributable interest in any other broadcast station. No consideration or thing of value is being given for the interest being transferred.
